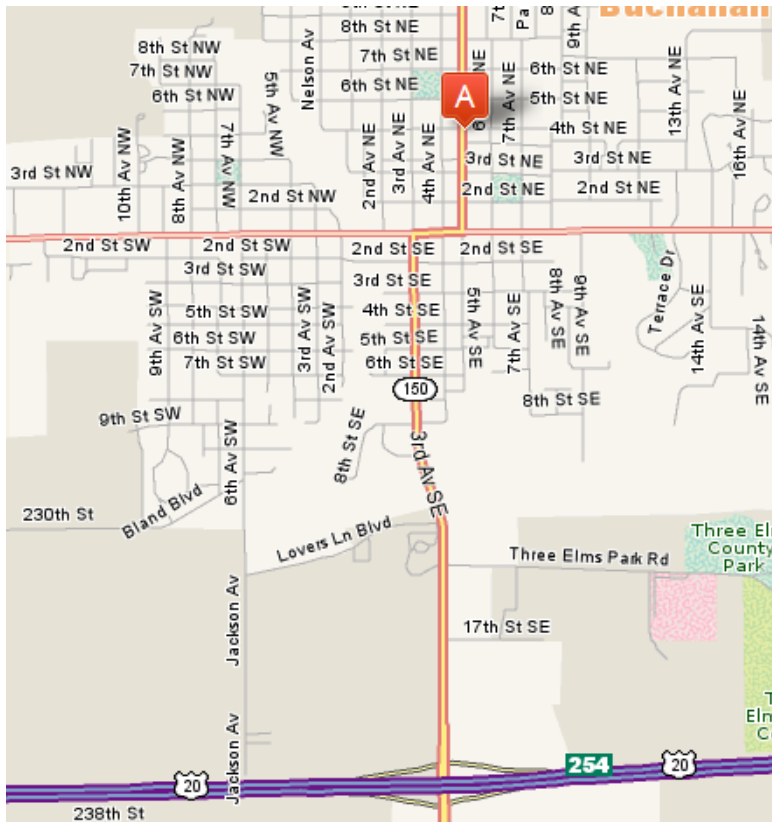
**Re: 2012 NE Iowa 4-H Exhibit Judges' Training**

**4-H Exhibit Judges' training** will be held on Saturday, February, 25<sup>th</sup> 2012 in Independence, Iowa at Immanuel Lutheran Church. The training is designed for individuals with an interest in becoming a 4-H judge, along with updating current 4-H judges. Project areas covered include communications, photography, personal development, food and nutrition, agriculture/ natural resources and science/technology, in addition to with a session focusing on 4-H judging basics. Anyone with skills or expertise in any of the project areas listed is encouraged to attend this training. Participants who complete training are eligible to be included on the Iowa 4-H judges' database and judge county fairs and 4-H events in their respective project area.

Registration will begin at 8:30 AM with the workshop starting at 9:00 AM. Refreshments and handouts are included with the registration fee.
