This is a license agreement for the Welcome to Retirement curriculum materials (current web edition)(the "Materials") between _____ ("Licensee") and Iowa State University ("ISU").

1. ISU grants to Licensee the non-exclusive, non-transferable right to use the web site to create hard copy masters or electronic files of the Materials, suitable for printing the text of the Materials in accordance with the terms of this Agreement. In consideration, Licensee shall pay to ISU's Extension the license fee of \$45. Licensee may, subject to the conditions set forth in this Agreement, reproduce unlimited copies of the Materials over a three-year period from the date of this signed agreement in paper print format and distribute free or sell the Materials as needed for licensee's clients. Content of the Materials may not be changed. However, the Materials may be used in parts, making sure credit to Welcome to Retirement and Iowa State University Extension is clear on the parts. If the Licensee adds content, it must be clear that the additions are not part of the Materials. Neither the whole nor the parts of the Materials may be reproduced electronically, including reposting on the Internet or on a CD-ROM. The content of the Materials may be extracted for use for promotional purposes, in promotional material for the Materials, in press releases, or in audio or visual formats about the Materials. The electronic files of the Materials or their content may not be resold or otherwise transferred to another person, except that they may be provided to a printer for the purpose of printing as per this agreement. Licensee may add a cover sheet stating that the Materials are provided by the Licensee, but the original pdf format of the Materials may not be changed and the Iowa State University wordmark must be included.
2. If the Licensee sells the Materials, the Licensee may charge clients only the reproduction costs of client copies for the Materials.
3. ISU Extension will provide Licensee with a password for the restricted web site of the Materials after the agreement is concluded and receipt of \$45 from Licensee. ISU Extension also will provide an initial package of 30 game

boards (SP 244). Additional game boards may be purchased for 50 cents each.

4. Remittance shall be a check payable to Iowa State University, and the signed agreement shall be sent to the Communications Manager, Continuing Education and Communication Services (see address above).
5. This Agreement may be terminated in whole or in part in writing by either party, provided the other party is given not less than 30 days written notice of intent to terminate, and an opportunity to talk with the terminating party prior to termination. Licensee shall return the Materials to ISU within thirty (30) days of termination.
