

2010 MADISON COUNTY FAIR QUEEN PAGEANT RULES AND REGULATIONS

1. Each contestant must be at least 16 years of age and not more than 21 years of age on August 12, 2010.
2. Contestants must never have been married or have had children.
3. Each contestant must reside in Madison County, or an adjoining county if the majority of her activities are in Madison County.
4. Each contestant must be an active member of at least one service organization in her community such as a church group, 4-H, Girl Scouts, etc. (Eligibility is not limited to 4-H membership.)
5. Only winners as indicated in Rule 3 are eligible to represent Madison County at the state pageant. In the event the county queen is unable to participate, alternates will be considered in order of selection.
6. No professional model (one who has had ongoing employment in which modeling was the primary part of the job) is eligible to compete in the county pageant.
7. Any contestant selected as the Madison County Fair Queen may not compete in future contests. All other contestants meeting the above requirements are eligible for future pageants.
8. Contestants will be evaluated by a panel of judges approximately one week prior to the Madison County Fair coronation ceremonies, which will be held Wed., July 14. Selection will be based on personality, attitude, leadership and citizenship, appearance and awareness, overall charm and poise. Final selection will be announced at the coronation ceremonies.
9. Each contestant should be prepared to appear in an evening dress at the Wednesday evening coronation ceremonies on July 14.
10. The winner of the county pageant must agree to appear for the Madison County Fair Board in official capacities as requested throughout the fair.
11. The winner of the county pageant will be entered in the Iowa State Fair Queen Pageant in August. County queens will be guests of the Iowa State Fair Tuesday, August 10, through the time of crowning on Saturday afternoon, August 14. It is the responsibility of the Madison County fair queen to make arrangements for transportation to and from the state competition. Hotel accommodations will be made for the county queens only during the Iowa State Fair competition.

2010 Madison County Fair Queen Pageant Application

Each contestant must be at least 16 years of age and not more than 21 years of age on **August 12**, the first day of the 2010 Iowa State Fair. Civic and community organizations, 4-H clubs, and FFA organizations may nominate one candidate. Each candidate will be interviewed by a panel of judges at the Madison County Farm Bureau meeting room in Winterset. The applicant must adhere to the rules and regulations set forth for the Madison County Queen Pageant and the Iowa State Fair if chosen to represent Madison County in the state pageant.
