

Iowa 4-H Center Summer Camp

Store Form



Each day campers will have the opportunity to visit the camp store to purchase snacks or souvenirs. No cash is exchanged with youth during a camper's stay, so parents/guardians must turn in the store form and money either before camp or during check-in. Campers must have a store form on file to make a purchase at the store. On the last day of camp, each camper will be told their remaining amount to spend and what will happen to their remaining money (refund or donation). Money marked for refunds will be handed back to parents at check-out. Parents may also select to donate unspent money to our camp staff banquet we hold at the end of the summer or designate it toward the purchase of new program equipment for the Iowa 4-H Center. Due to our busy schedules at the end of the week **all donations will be taken out of the accounts on Friday night – therefore they will not be available to use at the store on Saturday morning, unless you mark the form for a refund.**

To prevent the temptation for over-spending and stomachaches, campers are limited to purchasing a maximum of two consumable items each day. This usually translates to one drink and one food item. There is no limit on personal needs, camp apparel, souvenirs, and other items. Fees range from .20 to \$1.50 for snacks, .10 to \$25 for toys, and \$5 to \$35 for camp apparel. The camp store will be open on both opening and closing days if you would like to purchase items for your child at that time.

PLEASE NOTE:

- This form and store money may either be mailed back in advance, or brought with you to camp on check-in day.
- Participants in our Girls Night Out and Dad & Me camps are allowed to keep camp store money on their person and are not required to complete this form.
- Your camper will need a new Store Form for each camp session they attend.
- CIT Campers and Volunteer Nurses will create their own camp store tab while at camp and then are required to pay their bill before they leave camp.
