



## ***Clay County 4-H Fund and Endowment Financial Assistance for 4-H Volunteers***

The Clay County 4-H Fund and Endowment Board has approved funds for use by 4-H volunteers who wish to participate in education programs and volunteer development opportunities in the Iowa Youth and 4-H program. These funds are intended to provide an opportunity for 4-H volunteers to participate in events or activities at the area, state, regional or national level.

### ***How to apply***

The following guidelines have been established for applying for financial assistance.

1. Any Clay County 4-H volunteer who is a participant in an Extension youth program or programs recognized by the 4-H program, is eligible.
2. An Extension staff member on behalf of the volunteer or a volunteer leader may submit an application using a copy of the Financial Assistance Application form, 4H FAAV-0404b-CC.
3. Participants may be asked to bear some portion of the activity cost. The participants may apply to the Iowa 4-H Foundation for additional assistance.
4. The County 4-H Fund and Endowment has a limited amount of money for financial assistance. The funds will be allocated among as many different individuals as possible. Therefore, individuals may request assistance one time per year.
5. Financial assistance applications should be made prior to the event. This will allow a more careful analysis of requests and allocation of funds.
6. The applicant should attach a brief (one page or less) statement of what they hope to gain and how they will share the information as a result of their participation.
