



Buena Vista County 4-H Fund and Endowment Financial Assistance for 4-H Volunteers

The Buena Vista County 4-H Fund and Endowment Board has approved funds for use by 4-H volunteers who wish to offer and/or participate in educational programs and volunteer development opportunities in the Iowa Youth and 4-H program. These funds are intended to provide an opportunity for 4-H volunteers to participate in events or activities at the area, state, regional or national level and/or enrich an activity or event for 4-H Youth groups.

How to apply

The following guidelines have been established for applying for financial assistance.

1. Any Buena Vista County 4-H volunteer who is a participant in an Extension youth program or programs recognized by the 4-H program, is eligible.
2. An Extension staff member on behalf of the volunteer or a volunteer leader may submit an application using a copy of the Financial Assistance Application form, 4H FAAV-0404b-BV.
3. Participants may be asked to bear some portion of the activity cost. The participants may apply to the Iowa 4-H Foundation for additional assistance.
4. The Buena Vista County 4-H Fund and Endowment has a limited amount of money for financial assistance. The funds will be allocated among as many different individuals as possible.
5. Financial assistance applications should be made prior to the event. This will allow a more careful analysis of requests and allocation of funds.
6. The applicant should attach a brief (one page or less) statement of what they hope to gain, how they will share the information as a result of their participation and/or what they hope as the outcome from the activity/event in which they are requesting funds.
