How many people called?

Teen Line received 212 calls for the month of January. This is an increase of 6 calls from the previous month. The annual total (fiscal year) of calls from October 2002 – January 2003 is 742.

Who called?

The average caller was 16 years old, female (42% female, 29% male), and remained on the line for 4 minutes. Eleven percent of the calls were made by adults. Seven percent of the callers were using our service for the second time or more.

Topics of discussion:

The greatest number of calls were categorized as relationship concerns (9%). Of these twenty calls, 62% revolved around family issues, 14% to peer/friend issues, and another 19% were concerned about boy and/or girl relationships.

The remaining calls were categorized as follows: abuse (9 or 4%), birth control (4 or 2%), brochure request (5 or 2%), educational (5 or 2%), foster care/aftercare (6 or 3%), hang-ups (62 or 29%), health (15 or 7%), information about hotline (7 or 3%), legal (2 or 1%), lonely or just needed to talk (11 or 5%), other (22 or 10%), prank (16 or 8%), pregnancy (12 or 6%), sexuality (8 or 4%), suicide (1 or 0%), and wrong number (17 or 8%).

What was the outcome of the calls?

Of the 212 calls, 60 (28%) required a listening ear and counseling that the Teen Line staff provided. In addition, 17 callers (8%) had a specific question that staff was able to answer. To supplement the information given by staff, 38 referrals (18%) were made. Staff was unable to help the 78 callers (37%) that hung-up or made a prank call.

To whom were the callers referred?

Of the referrals that were made, 5% were to a counselor other than their school counselor, 10% were to a family planning center, 26% to medical services, 2% were to the caller's parents, 14% to another hotline, 7% to school personnel, and 26% to medical services. Six callers (14%) were referred to the Iowa Aftercare Services Network.
