

# 2024 Share a Pig Contract

- Exhibitor will be required to exhibit their pig at the 2024 Bremer County Fair.
- Exhibitor will be required to pay the Bremer County Fair Association (BCFA) 50% of the original cost of their pig at the time of 2024 Fair Weigh In/Check In.
- Pig(s) must be picked up on Saturday, April 6 at the Bremer County Swine Weigh In.
- The exhibitor must pay full purchase price in the event the pig is not exhibited at the 2024 fair. This payment must be received at the time of the 2024 Fair Check In/Weigh In. The BCFA/CYC reserves the right to amend this rule due to extenuating circumstances. The BCFA/CYC needs to be contacted prior to fair if you believe such circumstances exist.
- The BCFA remains the owner of the pig until it is paid for at the 2024 fair. The pig cannot be sold under any condition prior to fair.
- In the event of the pig's death, BCFA will pay fair market value at the time of death minus the full cost of the pig because it did not show at fair.
- Exhibitor must sign this contract along with at least one parent/guardian.
- Exhibitor is responsible for meeting the sign up and Swine ID requirements by May 15, 2024. Exhibitor must register their pig through Fair Entry by July 1, 2024, to be eligible to show the 2024 Bremer County Fair.
- It is understood this contract represents an agreement between exhibitor, parent/guardian, and Bremer County Fair Board Association
