STATIC 4-H EXHIBIT CLASS CHANGES FOR 2023

General Rules

.#7 – updated link to correct one

#8 – added "Audio or video should not be longer than 10 minutes and must be uploaded to YouTube."

#9 – spelled out "inches" instead of using ", for accessibility

#18 – changed the rule to align with Iowa State Fair. Links also added. Rule:

"Endangered, threatened, and "special concern" plants and animals (including insects), or songbird feathers and nests may NOT be used in any exhibit. Game animals legally taken are acceptable, with the exception of any hogs (Sus species) - per State Law. Live specimens of noxious weeds or invasive species are NOT permitted in any exhibit. Dried specimens are acceptable to use in exhibits, however viable noxious/invasive plant seeds shall not be included. (Links to specific information below)

10230: Horticulture and Plant Science - added clarification at the end, (Garden crops and herbs are exhibited in classes in the Horticulture Department. Reach out with questions.)

10310: Music – added "If submitting a video or musical arrangement, it must be uploaded to YouTube."

10320: Photography - spelled out "inches" instead of using ", for accessibility

10340: Creative Photography – spelled out "inches" instead of using ", for accessibility

Family and Consumer Sciences Division

10410: Child Development – added to description "An exhibit could include careers in child development, caring for children with special needs, childcare, growth and development, or safety and health. An exhibit that includes items intended for use with children, such as babysitting kits, books, learning games, or toys, must include information about what you have learned about children while creating and using the exhibit OR what the child/children learned from their use of the item(s) in the exhibit."

10445: Food and Nutrition – updated year to 2023

10520: Communication – added "If finished exhibit includes audio or video, it must be uploaded to YouTube."

- 2. Reason: Judges look for this information in the member's write-up in this department. We should state this up front for members.

Updated expectations to include photo.

Removed specifics that are included in the mailed letter after recipients are selected. Added entire rules section.

Horticulture Department

Added clarification about entries in this division.

Added rule #1 – "Entries in this department are NOT eligible to advance to the lowa State Fair. Entries are allowed to receive a purple ribbon classification at the discretion of the judge."

Communications Department

General

#4 – added "Tentative date options for Clinton County are 8/8, 8/12, 8/13, 8/17." #10 – added "At the Iowa State Fair, stickers are not allowed in the 4-H Exhibits Building. Stickers may not be used in any Communication Event for any reason." #11 – added "If live animals will be used as part of a Communication Event, the exhibitor must comply with the 2024 Health Requirements for the Exhibition of Livestock, Poultry and Birds at State Fair, District Shows and Exhibitions. This can be found at https://iowaagriculture.gov/animal-industry-bureau/animal-admission-health-requirements."

Working Exhibit

#6 – added "4-H members may participate in one Working Exhibit per year at the lowa State Fair."

4-H Communications Poster

#10 – updated themes to include:

- I <3 4-H (2023 National 4-H Week theme)
- Explore the Jungle of Opportunities in 4-H (variation of 2024 Iowa 4-H Youth Conference theme)
- 4-H Fever (variation of 2024 Iowa State Fair theme)

Added clarification: In Clinton County, Posters can also be judged on Conference Judging Day. The exhibitor can talk with a judge about their poster to receive a second opinion. State Fair selections will be made during the pre-fair communications day.

Awardrobe Clothing Department

#1 – updated date/time to Tuesday July 9, 2024 from 4:00 pm to 8:00 pm. Moving an hour later because many exhibitors couldn't attend before 4:30 before.

New #2 – clarified and combined with former rules #3-4 to better convey judge expectations and required documents.

#3 – added "It is expected that exhibitors will attend." In reference to the Fashion Show. #8 – added "Exhibitors may only have one entry per class. Example, one \$20 challenge entry and one Clothing Selection entry." This is due to scheduling needs and exhibitors should be bringing their best work for each class.

Removed former rule #7 about design elements and principles. These are not included on the updated forms and are no longer needed.

CLOVER KIDS SECTION CHANGES FOR 2024

Schedule change for 2024 – moving the Clover Kids show to the beginning of the 4-H/FFA show. Time as listed on the fair schedule. Go oldest to youngest so 3rd grade, 2nd grade, etc. After Clover Kids, move into the 4-H/FFA show. Update dates/times/locations to match fair schedule.

LIVESTOCK EXHIBIT CLASS CHANGES FOR 2024

Most approved October 2023. **approved December 2023.

Updated 2023 to 2024 as relevant

General Livestock Rule #9 – added "...AND the Fair Board Club Show Committee..." to state "The Livestock Superintendents, in consult with the Clinton County Club Show Veterinarian AND the Fair Board Club Show Committee, may approve or deny requests for livestock to be released early."

**Add rule "Any artificial means of removing or remedying physical defects of conformation in animals exhibited will be considered fraud and deception. No unnatural means of providing an animal feed, air, water or other fluid (i.e. stomach pump, drenching, IV) will be allowed. All animals giving evidence of such treatment will be barred from exhibition."

**FFA Youth will use FairEntry to identify their animals by May 15th. This will be changed throughout the book. (*Please note, we previously used a Google Spreadsheet but FairEntry has made updates to make this process easier. Advisors all agree to use this for 2024.*)

**General Livestock old rule #13 was eliminated – "No 4-H or FFA members may remain on the grounds between the hours of midnight and 5:00 a.m." (Nobody was policing this rule.)

Beef Department

**Added Rule #16 - Any artificial means of removing or remedying physical defects of conformation in animals exhibited will be considered fraud and deception. No unnatural means of providing an animal feed, air, water or other fluid (i.e. stomach pump, drenching, IV) will be allowed. All animals giving evidence of such treatment will be barred from exhibition.

Cow-Calf Classes

#2 – updated calf birthdate "...January 1, 2024..."

#4 – added "2nd year bucket bottle calf..." to state "To be eligible for a cow-calf class, the cow must have been identified to show at a previous Club Show as a 2nd Year Bucket Bottle Calf, commercial breeding, or registered breeding heifer by the exhibitor." +1 to each of the class years

#26 – New rule – "Exhibitors must participate in a showmanship class (510:12 or 510:13) in order to participate in performance or speed division classes (511: and 512:)."

#27 – New rule – "For speed events, exhibitors must walk their horses/ponies into the arena and mount/dismount in the arena."
