Code of Ethics

Youth are expected to be sincere, honest and act in sportsmanlike ways at all times. Youth represent the entire program and their behavior reflects on their parents, leaders, club and the entire youth program. All adults involved with the youth program, leaders as well as parents, are expected to set positive examples and serve as positive role models by what they say and do. Any youth who breaks the Code of Ethics or allows another person (adult or peer) to talk them into violating the Code of Ethics agrees to forfeit all prizes, awards and premiums. The youth may also be prohibited from exhibiting at this and future exhibitions including the Emmet County Fair and other county, state or regional exhibitions.

Youth agree to follow these guidelines:

- 1. I will do my own work, appropriate for my age and physical and mental development. This includes research and writing of exhibit explanations, preparing exhibits (such as sewing, cooking, refinishing, etc.), care and grooming of animals, etc. Adult assistance should help guide and support me, not do it for me.
- 2. All exhibits will be a true representation of my work. Any attempt to take credit for other's work, alter the conformation of animals, or alter their performance is prohibited. Copyright violation or allowing others to complete your exhibit is considered misrepresentation and is prohibited.
- 3. I will treat all people and animals with respect. I will provide appropriate care for animals.
- 4. I will present exhibits that are safe for consumption. All food exhibits will be safe to exhibit and for judges to evaluate. Other exhibits will be safe for judges to evaluate and for exhibition.
- 5. All food animals that may be harvested immediately following the show shall be safe for consumers and shall have met all withdrawal times for all medications, and be free of violated drug residue.
- 6. If any animal requires medical treatment while at the fair or exhibition, only a licensed veterinarian may administer the treatment. All medications that are administered shall be done according to the label instructions of the medication used.
- 7. My animal's appearance or performance shall not be altered by any means, including medication, external applications, and surgical procedures. Any animal that is found to have changed its appearance or its performance shall be disqualified from the show, and have penalties assessed against the exhibitor, parent and/or guardian by the management of the fair or exhibition.
- 8. I will follow all ownership and possession rules and, if requested, will provide the necessary documentation.
- 9. I will follow all livestock health requirements for this fair or exhibition, according to the state health requirements as printed in the premium book of the fair or exhibition. I will provide animal health certificates from a licensed veterinarian upon request from the management of the fair or exhibition.
- 10. By my entering an animal in this fair or exhibition, I am giving consent to the management of the fair or exhibition to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. If the laboratory report on the analysis of any sample indicates a presence of forbidden drugs, this shall be evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the exhibitor, parent and/or guardian to prove otherwise.
- 11. I am responsible for my exhibit, and I will not allow others to violate this code on my behalf. By my entering an exhibit in this fair or exhibition I will accept any disciplinary action taken by the management of this fair or exhibition for any violation of this code of ethics and any other rules of competition of the fair or exhibition without recourse against the fair or exhibition.
- 12. I want my exhibit to be an example of how to accept what life has to offer, both good and not so good, and how to live with and learn from the outcome.
- 13. I will not be involved in any illegal activities while participating in 4-H and FFA events, including but not limited to alcohol, tobacco, or drug use.

I agree to conduct myself in an honest, ethical, and upstanding manner and I understand that disciplinary actions will result if these rules are violated. I understand that I am expected to represent the program in a positive manner. I have read, understand, and agree to follow this code of ethics, and any other rules of competition of the fair or exhibition as printed in this premium book.

Code of Conduct for Youth and Parents

The Iowa 4-H Code of Conduct applies and will be enforced with 4-H youth, 4-H parents/guardians, and 4-H families.

- While participating in or attending a 4-H sponsored program (e.g. club meeting, project meeting, activity, event, learning opportunity).
- While participating in or attending a 4-H event or while on premises used for 4-H purposes (e.g. County Fair, State Fair, show ring, exhibit building, barn, food stand).
- While representing Iowa 4-H to the public
- Additional programs, events, or opportunities may have additional rules and expectations.
- At all times throughout a 4-H youth's participation when behavior outside of the Iowa 4-H puts youth at risk or has the potential to put youth at risk.

The opportunity to participate in and/or volunteer with Iowa 4-H is a privilege and honor, not a right. All youth participants and parents/guardians supporting their child's participation in 4-H are expected to review and agree to abide by the Iowa 4-H Code of Conduct before becoming involved with Iowa 4-H.

- 1. I understand that the Iowa 4-H Youth Development program is a non-formal education program in which I have a choice to participate. I accept my responsibility to engage in program activities and to excuse myself from this program if it does not meet my personal learning objectives. I recognize the organization has the responsibility and authority to remove youth who are disruptive to the 4-H Youth Development program, violate the Iowa 4-H Code of Conduct, the standards of the 4-H Pledge and Motto or federal, state or local laws.
- 2. I accept my responsibility to represent the Iowa State University Extension and Outreach 4-H Youth Development program by holding myself to the standards of the 4-H pledge and motto. I will refrain from behavior that negatively represents myself, my family, my community, 4-H or Iowa State University. I will act in a respectful and responsible manner during all 4-H programs.
- 3. I acknowledge that the 4-H program utilizes competition related to project work as a tool for learning. I will ensure that my project exhibits are appropriate and respectful. I will demonstrate good sportsmanship, encourage this behavior in others, and not allow this behavior to detract from the learning experience. I will not let my personal desire to win overshadow the needs of the group.
- 4. I accept my personal responsibility to be informed and follow the policies, rules, and deadlines established by Iowa 4-H. I will not cheat, lie, knowingly furnish false information, deceive, or otherwise engage in dishonest, unethical or illegal behaviors. I will not encourage others to disregard or intentionally violate conditions of Iowa 4-H participation.
- 5. I will comply with directions of 4-H officials acting in the performance of their duties. I will not obstruct or disrupt any 4-H program or encourage others to engage in such conduct. I understand that a judge's decision is final.
- 6. I will strive to be a positive role model. I will treat youth, parents, volunteers, extension and outreach staff, judges and others with respect, courtesy and consideration.
- 7. I will communicate (oral, written and electronic) in an open, honest, respectful manner in all situations involving the 4-H program. I will refrain from communication that is negative, offensive, destructive or hurtful to others. I will refrain from sharing private matters in a public group setting.
- 8. I will promote a spirit of inclusion and welcome participation of individuals from all backgrounds. I will not engage in or tolerate harassment in any form, (For example bullying, slander, put-downs, insults, taunting, name calling, yelling, profane language, sexual innuendos and other comments or hostile behaviors likely to offend, hurt or set a bad example.)
- 9. I will ensure a safe environment for myself and others by not carelessly or intentionally harming youth or adults in any way: emotionally, mentally, physically, socially, verbally or non-verbally.
- 10. I will not possess, offer, or use tobacco, electronic smoking devices (including but not limited to e-cigs, vapes, juuls), alcohol or illegal substances. I will not attend 4-H programs under the influence of alcohol or any illegal substance.
- 11. I will respect the property of others. I will not use, abuse, or take another individual's personal belongings. I will not damage facilities.

Infractions to the Iowa 4-H Code of Conduct will be addressed by the Iowa 4-H Program, the local County Extension District, or their appointed representatives. Infractions to the Iowa 4-H Code of Conduct will result in consequences. The consequences may range from a verbal warning to the loss of privileges (e.g. participation at the event or future events, forfeiture of awards or other forms of recognition, forfeiture of positions of leadership, limitation on volunteer responsibilities) to full removal from the Iowa 4-H Program

4 Meeting Rule Policy

Any Emmet County 4-H member who is in good standing and eligible to participate in the Emmet County Fair must meet the following criteria:

- 4-H Program development fee is paid to the County Extension office (member dues)
- Successfully met all the required deadlines
- Compliance with the meeting attendance requirement, 4 club meetings by June 30.
- Individuals exhibiting livestock must have their YQCA training completed by July 1st.
- 4-H members that have no more meetings in their club, are not allowed to attend another club to get their last meeting.
- July meeting will not count as one of the four required meetings.

All decisions made by the Emmet Extension Council are final. If clarification or reasoning needs to be communicated, a formal statement can be requested from the council.

Special Accommodation Request

The Emmet County Fair Board and Iowa State University Extension and Outreach of Emmet County strive to make its programs and events accessible to all citizens who are otherwise eligible to participate in the activities. Reasonable accommodations are often possible for persons with disabilities who wish to participate, so long as the accommodations do not fundamentally alter the nature of the program, cause undue financial burden, or otherwise cause a direct threat to the health or safety of others. Please know that while not all specific requests may be approved, the Emmet County Fair Board and Extension and Outreach Staff will work with the participant to identify other accessible means to participate.

An individual requesting accommodation to participate in the Emmet County Fair should submit a completed Special Accommodation Request Form (available at the Emmet County Extension Office) to the Extension Office, (26 S. 17 St., Estherville). Because it can take time to plan for some accommodations, it is requested that the form be submitted six (6) weeks prior to the event or activity. Submitting a Request for Services on short notice may reduce or limit the ability to implement the accommodations.

4-H/FFA Protest Policy

When Iowa 4-H members participate in events, rules and protocols are written to ensure safety and integrity for all participants. In some situations, Iowa Exhibitor Youth Code of Ethics, The Iowa 4-H Code of Conduct for Youth/Families, Fairbook rules and guidelines, and other event rules are not followed as stated, which leads to decisions being made during those situations that impact participation for that event. Before a grievance is filed, ensure that the department superintendent and affected exhibitor has been consulted. If a resolution cannot be reached the following procedures are in place.

Protests & Appeals

It is important to note that some decisions cannot be protested/appealed through this process. These include:

- Decisions made by judges, which are final.
- Issues related to deadlines for 4-H enrollment, livestock identification, and/or county/state fair entry deadlines.

• Any requests for rule clarification or rule changes for the next year can be shared directly with the Extension office and do not need to be included in this process.

Who may submit?

- Any Iowa 4-H member or FFA member and his/her/their parent or guardian.
- Only participants entered in the same department can file a protest or appeal of disciplinary action.

Who responds?

• A committee that has been established that includes: a council member, a regional extension representative, a county 4-H staff member or FFA advisor, any non-related committee superintendent, and a Fair Board member.

Process for individuals filing a protest or complaint

- During the county fair, protests/complaints must be filed within 6 hours of the incident and no later than 2 hours before the show for the decision to go into effect.
- Protests/complaints must be submitted in writing and must include:
 - o Names of persons involved AND cause of protest or complaint
 - o Date and time of incident
 - o Specific action, rule, etc., in question
 - o Situation and documentation
 - o Additional persons the committee may contact for further clarification
 - o Signature of 4-H member or FFA member and their parent/guardian filing the protest or complaint
- o \$100 cash deposit fee. If the protest is successful, the fee will be returned to the exhibitor. If the protest is unsuccessful, fees will go to 4-H scholarships and funds.
- The written protest/complaint must be submitted in a sealed envelope to the 4-H office or staff member on the Emmet County Fairgrounds.
- Committee will address protest/complaints and relay a decision within 48 hours. This decision will be final.

Entry fees must be paid online when entering for the Emmet County Fair or by check payable to "Emmet County Fair Board" following online entry and turned into the Extension Office—payment deadline is July 18th. FFA exhibitors must pay by check. No refunds of entry fees.

Exhibitors must have fees paid to be eligible to show at the fair. Fees must be paid in order to be approved.

GENERAL EXHIBIT RULES

- 1. Premiums: Blue: \$5.00, Red: \$4.00, White: \$3.00
- 2. Livestock must be in their stalls or pens by designated time on the schedule.
- 3. All livestock housed at the fairgrounds (including horses) that are not going through the Market Auction or on the truck to a packer will be released on Sunday at 5:00 PM.
- 4. The area east of the bucket/bottle barn will be reserved for horse trailers, horse vehicles, and horse equipment ONLY!!!
- 5. NO animal equipment within 6 feet of the horse barn. This includes tarps, extension cords, animals, generators, etc.

- 1) Extension cords must not be in reach of or accessible to the horses.
- 2) South of the bucket calf and bottle lamb barn there is to be zero fitting. You are only able to work in front of your stall assignment
- 6. Entries are limited to active members of an Emmet County 4-H Club. Active FFA members are eligible to exhibit if they reside in Emmet County or are a member of an FFA chapter whose school district lies in Emmet County. FFA members are NOT eligible to show livestock at the Emmet County Fair if they are showing that same animal(s) at another county fair exceptions would be Clay County Fair or any other fair with an open or district show. If this is not followed, you are subject to consequences determined by the Fair Board.
- 7. Eligibility to exhibit is limited to those 4-H and FFA members who have completed 4th grade through 12th grade. Eligibility continues through the calendar year of their high school graduation.
- 8. All animal entries must be made through the www.fairentry.com site by 4 PM on July 8th by 4-H
 Members. If you do not have internet access, please enter using a computer at the Extension Office or
 another public computer. FFA members will make entries with FFA Advisors. NO animal entries will be
 accepted after the deadline.
- 9. Exhibits entered late will not be allowed at the fair. Animal Care and Disclosure Statement for Market Beef, Sheep, Meat Goat and Swine, are due at your barn meetings.
- 10. All livestock must be owned & exhibited by 4-H/FFA members. **EXCEPTION: Horse and dog project animals can be identified by more than one 4-H member provided the members are all 4-H members and are siblings. Sibling definition includes brother, sister or step-siblings with one common parent/guardian. The same animal(s) cannot be identified by one sibling in 4-H and another sibling in FFA.
- 11. A project cannot be entered as both 4-H & FFA. An animal ID'd as a 4-H animal remains a 4-H animal for the duration of that year. An animal ID'd as a FFA animal remains a FFA animal for the duration of that year.
- 12. All 4-H Livestock must be ID'd at https://v2.4honline.com by May 15th. Exceptions to this are:
 - 1) 4-H Market Beef weighed in (Dec): weights and animal information must be verified by February 1st.
 - 2) Rabbits, Poultry, & Pets must be ID'd by July 1.
 - 3) FFA Livestock must be ID'd with the FFA advisor by **May 15** and a copy advisors take, is given to the Emmet County Extension Office.
- 13. Owners must show their own animal (except in cases of sickness or other unavoidable circumstances when another member may show the project if they obtained approval from County Youth Coordinator). Exceptions: Dog and Horse—See specific species rules.
 - **Substitute Showman Policy:** Excusing a member from personally exhibiting his or her animal(s) defeats one of the important objectives of 4-H work. Hence, we are requiring livestock exhibitors who know in advance that they are not going to be present or are unable during the fair to show their own animal(s) to file a letter requesting a substitute showman no later than **July 8th** to the Emmet County Extension Office. In this letter, exhibitors are asked to name a substitute showman. The substitute showman must be an eligible Emmet County 4-H/FFA member in grades 4th-12th. Exceptions for the July 8th deadline will include injury, serious illness, bereavement, other state 4-H/FFA activities, unforeseen events, or other extreme emergency situations. Exceptions will be taken up until one hour prior to the start of the respective animal show with a contact made to the Extension 4-H Office at the fair. The respective livestock committee reserves the right to accept or reject any application.
 - **Substitute Showmanship Policy:** In order to participate in a livestock showmanship class (not including Supreme Showmanship), you must have the animal registered and present at the fair in your name.
- 14. Exhibitors with one animal per class must show their own animals. If they have more than one animal in a class, an Emmet County 4-H or FFA member, in grades 4th-12th, may assist, with prior approval by the superintendent of the department at the time of the show.
- 15. All exhibitors (except dog, horse, and pet exhibitors) must have current YQCA certification completed by **July 1**st.

- 16. Livestock committees/superintendents of each division shall have complete charge of all entries in their division. They may rule ineligible any exhibitor not present when classes are called for judging.
 - 1) Livestock Committees reserve the right to break classes at their discretion.
- 17. Only exhibitors and authorized fair officials may be in the show ring during the livestock shows. If this is an issue, you will receive a verbal warning and may be subject to disqualification, unless special need accommodations are requested and approved.
- 18. Every effort will be made to protect exhibitors, spectators, and livestock from accidents. The Emmet County Fair Board of Directors, however, or any other fair official will not be liable for accidents. A watchman will be provided Wednesday through Saturday nights.
- 19. All classes will be placed by a judge in blue, red, and white ribbon groups according to merit/quality of livestock/animal and all decisions of the judge will be final.
- 20. Each exhibitor must provide feed for their livestock while it is on the grounds. Please make sure animals also receive adequate water.
- 21. The Fair Board will provide wood shaving bedding for all animals. Extra bedding will be available for purchase in the Fair Board office. **STRAW IS NOT ALLOWED.**
- 22. Each exhibitor is responsible for keeping his/her pens or stalls clean and the aisles swept out. Pens need to be cleaned out by 10 AM on Monday. The Emmet County Fair Board reserves the right to withhold premium money from anyone not cleaning out their pens.
- 23. No grooming chutes/blocking chutes will be allowed in any livestock barns. They must be set up between the barns in front of their stalling areas. If more room is needed, ask permission once neighbors are set up! Please make sure to have all tents tied down and are secure!
- 24. Only overhead hanging fans will be allowed. No behind fans.
- 25. Once checked in, NO livestock are allowed on the north side of the barns or outside of the brown fenced in areas, unless an exception is made by the specific livestock committee. Horses are exempt during show times. If you do not follow this rule, you will receive **ONE** verbal warning. After the warning, you will be subject to disqualification.
- 26. Health certificates will not be required on livestock showing at the fair. They will all be inspected by the Official Fair Veterinarian. The 4-H Staff person, Extension Council member, Fair Board member, Livestock Committees, and a regional ISU Extension and Outreach staff will adhere to the diagnosis, treatment, and prevention of diagnosed disease by the Official Fair Veterinarian which could include of removal of the animals from the fairgrounds. Animals will be subject to daily inspections throughout the fair.
- 27. No unnatural means of providing an animal feed, water, or other fluid (i.e. stomach pump) will be allowed unless administered by the official fair veterinarian for health reasons.
- 28. No watering down of the animals is allowed in any barns/pens.
- 29. No exhibitors/families will be allowed to stay overnight on the fairgrounds unless prior approval is granted from the fair board.
- 30. No alcoholic beverages are allowed on the fairgrounds.
- 31. It is mandated by all committees that you wear a 4-H shirt for showing all 4-H exhibits and FFA shirt while exhibiting all FFA exhibits. Also, all exhibitors must wear jeans/pants and close toed shoes or boots. No hats are allowed during exhibiting/judging. Horse exhibitors refer to the 4-H Rules & Regulations for Equine Shows in Iowa, 4-H 511C.
- 32. All livestock trailers should be parked on the southwest side of the fairgrounds along the fence.
- 33. If there is a situation where a 4-Her has two or more animals in the same class, the 4-Her is required to find a 4-Her that is in good standing and eligible to show at Emmet County Fair. *See 4 meeting rule p. 6*
- 34. Exhibitors shall act appropriately at all times. Unnecessary roughness or discourtesy will dismiss the exhibitor from further competition for the entire show. Good sportsmanship should prevail. Courtesy is mandatory. No abuse (hitting, kicking, etc.) of animals will be tolerated. Each exhibitor must keep their animal under control or they will be excused from the show ring. Any abusive care or excessive modification of animals by parents or exhibitors will be disqualified.

- 35. There will be no smart watches on or phones in pockets while in the show ring.
- 36. Stall cards will be posted by Thursday at noon. 4-H club leaders will be contacted if cards are not posted.
- 37. As a group, the County Youth Coordinator, a Regional ISU Extension and Staff Representative, a Emmet Extension Council member, Count Fair Board member if applicable, and a Livestock Committee representative reserves the right to interpret all non-health related rules. All decisions are final.
- 38. Every attempt will be made to get premium checks, auction checks, and market livestock checks released to families in a timely manner after. Auction checks and market livestock checks will need to be signed out at the office and will not be mailed. Families will be notified when checks are available to be picked up.
- 39. Read the SPECIAL RULES for each division.

4-H/FFA Market Livestock Premium Auction

Market beef, market swine, market sheep, market meat goats, market rabbits, & market poultry are all eligible to participate in the 4-H/FFA Market Livestock Premium Auction on Sunday. The 4-H/FFA member will receive a premium and will retain ownership of the animal. Youth will walk their animal through the ring (you must be with your animal and ready to go or forfeit), except for pens of three cattle, where exhibitors will go through the ring with their ribbon. Premium bids will be accepted in flat dollar amounts, NOT dollars per hundred weight. The animal itself is not offered for sale. Youth can go through the sale ring for a total of up to 3 times maximum, with the following guidelines:

SWINE: If you bring 5 or less market swine, you may go through the auction ring once. In order to go through the auction ring twice, you must bring 6 market swine.

SHEEP: If you bring 5 or less market sheep, you may go through the ring once. In order to go through the auction ring twice, you must bring 6 market sheep.

MEAT GOATS: If you bring 5 or less market meat goats, you may go through the ring once. In order to go through the auction ring twice, you must bring 6 market meat goats.

BEEF: Each exhibitor may take up to 2 market beef through the auction ring. Pens of three market beef would count as one trip.

MARKET RABBIT <u>OR</u> MARKET POULTRY: Each exhibitor may go one time through the auction ring maximum – with <u>EITHER</u> one market poultry <u>or</u> one market rabbit. (The animal must be entered in a MARKET class to qualify.)

There will be a \$7.50 auction fee per animal that you pay when you sign up to go through the 4-H/FFA Market Livestock Premium Auction. This auction fee is due with fair entries by July 8th (either paid online with a credit card or by check payable to the "Emmet County Fair Board"). Participants need to decide when entering for the Emmet County Fair which species of animals they plan to bring through the auction. The auction fee is used to help defray auction expenses. No refunds on auction fees paid.

It is required that <u>anyone</u> participating in the 4-H/FFA Market Livestock Premium Auction <u>must</u> wear a 4-H or FFA shirt and appropriate pants or jeans (no shorts or capris), no hats, and no open toed shoes. (If you do not follow these guidelines, you will not be allowed to participate in the premium auction.) 4-H and FFA members must be present and accompany their own livestock through the auction ring.

**Auction order will be posted one hour before the auction begins. (It's also posted on the back of fair book)*
Livestock committees for beef, sheep, meat goats, and swine will attempt to arrange for transportation and will attempt to obtain bids for 4-H or FFA members wanting to sell their animal to the pack, if possible. 4-H/FFA members can elect to take sheep, meat goats, swine, and beef projects home or sell them with the bid presented.

Supreme Showmanship Contest

The senior age (9th-12th grade) winners (1st through 5th place) of Beef, Sheep, Goat, and Swine Showmanship will compete Friday evening following beef showmanship for the "Supreme Showman" title.

- 1. If one of the 1st through 5th place exhibitors of Beef, Sheep, Goat, & Swine Showmanship has won the Supreme Showmanship in past years, they will not be eligible to participate. The Beef, Goat/Sheep and Swine Committees would ask the next place show person.
- 2. If one of the members decides they do not want to participate in the Supreme Showmanship Contest, they must notify the Livestock Superintendent (Beef, Goat/Sheep or Swine), so that the Superintendent and committees will be able to ask the next place show person to participate in the Supreme Showmanship Contest.
- 3. There will be a maximum of 12 exhibitors in the Supreme Showmanship Contest—3 from Beef, 3 from Swine, 3 from Sheep, & 3 from Goats. If an exhibitor qualifies to participate under more than one specie, they will start with the specie they received the highest place with. If there is an exhibitor that qualifies in more than one specie, there will be less than 12 participants in the contest.
- 4. Members will begin by showing their own animal and then show the other three species—in a round robin rotation system. 1st place winners will show 1st place animals, and so on. There will be a different judge for each specie.
- 5. Members will be given points by each judge based on presentation and handling of the animal (showmanship) for up to 40 points and specie knowledge for up to 10 points. There are 50 points possible per specie.
- 6. The Supreme Showman will receive a belt buckle and will not be eligible to win Supreme Showmanship again at the Emmet County Fair in future years.

Herdsmanship Contest

Herdsmanship is an important part of a 4-H livestock project and is expected for all exhibitors to take part in. It is also important that the public sees that our animals are well cared for. To provide a welcoming and attractive environment for the public and to provide animals with the best possible quality and care, we require all exhibitors to keep exhibit areas/stalls in good "herdsmanship" manners. This includes:

Cleanliness of alleys, stalls, or pens

- Bedding adequate, clean, dry and in place
- Manure cleaned out and deposited in proper place
- Alleys swept and as clean as possible

Appearance of animals

- o Animals clean and brushed
- o Animals properly tied or penned
- Animals are fed and watered as needed

Appearance of exhibit area

- Exhibit areas and stalls orderly and attractive
- o Stall cards complete, clean and displayed with stickers for ribbons earned attached
- Club signs neatly displayed
- Show boxes and equipment orderly
- "Extra" equipment stored out of the way
- Practice safe use of electric equipment

Conduct of 4-Hers and FFA members

- Act in an appropriate manner while on grounds
- o Promptness for shows and fair duties
- Courteous to others

Herdsmanship is expected throughout the entire duration of the fair, even after the animal's show is complete. ALL livestock barns will be checked throughout the fair at a minimum of twice daily at random times. Exhibitors are expected to uphold these requirements and practice the importance of animal husbandry. Exhibitors will be judged individually throughout each of the barns on the fairgrounds. Judges will evaluate exhibitor participation daily throughout the duration of the fair. Judges who find exhibitors not participating in good herdsmanship will give Extension staff their names. Exhibitors will receive one warning. If an exhibitor is still not participating in good herdsmanship after the first warning, the Emmet County Fairboard will withhold premium money until good herdsmanship is conducted.

Herdsmanship expectations will be posted in each barn.

THE EMMET COUNTY FAIR BOARD RESERVES THE RIGHT TO WITHHOLD PREMIUM MONEY FROM ANY INDIVIDUAL NOT DOING THEIR PART TO: KEEP THEIR PENS CLEAN, KEEP THEIR ANIMALS FED/WATERED, AND CLEAN UP AFTER THEIR ANIMALS.

Health Requirements of Livestock, Poultry & Birds

ANY EVIDENCE OF WARTS, RINGWORM, FOOT ROT, PINK EYE, DRAINING ABSCESSES OR ANY OTHER CONTAGIOUS OR INFECTIOUS CONDITION WILL ELIMINATE THE ANIMAL FROM THE SHOW.

- No individual Certificate of Veterinary Inspection will be required on lowa origin animals or poultry exhibited at a County 4-H/FFA FAIR, but the animals must be inspected when unloaded or shortly thereafter by an accredited veterinarian. Swine are required to be inspected before being unloaded or before leaving a designated isolation and inspection area (prior to mixing with any other pigs). All animals moving from out of state into an lowa county 4-H/FFA fair must meet lowa Animal and Livestock Importation requirements. Each show must have an official veterinarian.
- > Quarantined animals or animals from quarantined herds cannot be exhibited.
- Official identification listed on a Certificate of Veterinary Inspection required for all cattle and bison of any age coming in from out of state used for rodeos, recreational events, shows, and exhibitions.

SWINE—All swine must originate from a herd or area not under quarantine and must be individually identified. All swine are required to have individual official identification. All 4-H and FFA tags bearing the US shield are official identification tags. **Swine originating outside of lowa**—All exhibitors must present a test record and Certificate of Veterinary Inspection that indicates that each swine has had a negative test for pseudorabies within 30 days prior to the show, regardless of the status of the herd, and show individual official identification on test report. Electronic identification will not be considered official identification for exhibition purposes.

Swine exhibition requirements—"Swine exhibition" means an exhibit, demonstration, show, or competition involving an event on the state fairgrounds, a county fair, or other exhibition event. The sponsor of the exhibition must retain an lowa licensed veterinarian to supervise the health of the swine at the exhibition locations. The sponsor must electronically file the approved registration form and obtain approval from the state veterinarian at least 30 days before the event. The registration form includes the name of the exhibition and the address and telephone number of its location; the name, address and telephone number of the veterinarian; and the date of the planned exhibition. Sales of swine will not be allowed unless the event has been registered and received approval from the state veterinarian 30 days prior to the event.

Swine exhibition report required—The sponsor of the swine exhibition shall electronically submit to the department the approved report form within five business days after the conclusion of the exhibition. The form includes the name of the exhibition and the address and telephone number of its location; the name, address and telephone number of the veterinarian; the date that the exhibition occurred; the name, address and telephone number of the swine; and the address and telephone number of the premises from which the swine was moved after the exhibition if such premises is a different premises.

SHEEP & GOATS — All sexually intact sheep must have an individual Scrapie Flock of Origin identification tag (Ex. IA1234-5678) or another Official Scrapie tag. All sexually intact goats must be identified with an individual Scrapie Flock of Origin identification tag (Ex. IA1234-5678), another official Scrapie tag, or by an official tattoo registered with USDA (to register, call 1-866-USDA-TAG; 1-866-873-2824). Wethers less than 18 months of age are required to have an individual identification and a scrapie tag may be used, but a scrapie tag is not required.

<u>POULTRY & BIRDS</u> - All poultry exhibited must come from U.S. Pullorum-Typhoid clean or equivalent flocks, or have had a negative Pullorum-Typhoid test within 90 days of public exhibition and the test must have been performed by an authorized tester. Please note: Poultry purchased from a hatchery and raised for exhibition are not exempt from Pullorum-Typhoid testing requirements.

However, "Market Classes" of poultry consigned to a slaughter establishment are exempt from the Salmonella testing requirements. "Market Classes" of poultry must be separated from all other poultry by ten or more feet and/or an eight-foot high solid partition.

DOGS & CATS - All dogs and cats exhibited must have a current rabies vaccination certificate.

<u>FARM DEER</u> – Accredited veterinarians must be approved to administer tuberculosis tests on Cervidae.

"Cervidae" means all animals belonging to the cervidae family, and "CWD susceptible cervidae" means whitetail deer, blacktail deer, mule deer, red deer, elk and moose. Native Iowa Cervidae may be exhibited without other testing requirements when accompanied by a Certificate of Veterinary Inspection that lists individual official identification.

All Cervidae must have been part of the herd of origin for at least one year or were natural additions, or must have originated from a chronic wasting disease monitored or certified herd in which these animals have been kept for at least one year or were natural additions. Cervidae originating from a herd with a diagnosis, signs, epidemiological evidence, or area under quarantine for chronic wasting disease may not be exhibited. The following statement must appear on the Certificate of Veterinary Inspection:

"All Cervidae on this certificate have been part of the herd of origin for at least one year or were natural additions to this herd. There has been no diagnosis, signs, or epidemiological evidence of chronic wasting disease in this herd for the past year."

THE DECISION OF THE OFFICIAL SHOW VETERINARIAN WILL BE FINAL.

Beef Department

Show Order: 1) Cow/Calf Pair (grass area), 2) Pen of Three Market Beef (grass area), 3) Prospect Calf (show barn), 4) Breeding Heifer (show barn), 5) Market Beef (show barn) - Market Heifers, Market Steers ** There will be NO noon break during the show.

- 1. Lead calves will be stalled together by club—stall assignments must be followed as posted in the barns unless special permission is granted by the beef committee.
- 2. Neck ropes, in addition to halter, are REQUIRED on lead calves while tied in the barn at the fair.
- 3. Exhibitors can weigh-in a maximum of 10 market beef at an Emmet County site in December.
- 4. There will be **no** other tags allowed in the calves' ears, **EXCEPT** the 4-H or FFA tag.
- 5. Cable halters are not allowed.
- 6. ALL BEEF ENTRIES can enter the Ultrasound Contest. There is a grand and reserve banner sponsored for this extra opportunity. The cost is \$10/head. Exhibitors will be billed at the conclusion of the fair.
 - a. These animals will have ultrasound completed on Thursday July 25th at 10:00AM.
 - b. If pen of 3 animals want to participate in this contest, each head will be 'graded' individually.

MARKET BEEF INDIVIDUAL CALVES

Class No. 20260 - Market Heifers

Class No. 20210 - Market Steers

- 1. Each member may exhibit up to 3 market lead calves at the fair.
- 2. No market beef with horns over 1 inch in length will be permitted.
- 3. Each exhibitor must turn in their beef disclosure form at the Barn Meeting on Wednesday.
- 4. Upon weigh-in, market animals going on truck to the processing plant must be identified as you leave the scale. NO EXCEPTIONS.

- 1) If your animal is going on the truck, you are responsible for feeding and watering that animal until the truck arrives.
- 2) Market beef animals going on the truck to the processing plant will be entered in the carcass contest. Carcass ribbons/trophies will be given out after results are received following the fair.
- 3) Exhibitors will pay trucking fee, carcass collection fee, and dark cutter insurance fee; which will be deducted from paychecks.
- 5. Classes will be broken by weight. The committee reserves the right to establish as many classes by weight as they consider advisable.
- 6. There are separate classes that are established for the Market Steers and Market Heifers.
- 7. To decide an Overall Market Beef Selection, the top 3 from EACH MARKET HEIFER AND MARKET STEER CLASS will be brought back into the ring.
 - 1) The first market heifer to be picked will be the Champion Market Heifer.
 - 2) The second market heifer to be picked will be the Reserve Champion Market Heifer.
 - 3) The first market steer to be picked will be the Champion Market Steer.
 - 4) The second market steer to be picked will be the Reserve Champion Market Steer.
 - 5) The first Emmet County Born and Raised Calf will be the Champion Emmet County Born and Raised animal.
 - 6) The second Emmet County Born and Raised Calf will be the Reserve Champion Emmet County Born and Raised animal.
- 8. The top 3 in each class are eligible for the Overall Selection.
 - 1) A top 10 Market Animal will be chosen if there are 50 or more individual market calves entered into the fair.
- 9. A heifer showing in a market class CANNOT be exhibited as breeding heifer.
- 10. A heifer shown in this class the year prior will **NOT** be shown as a cow/calf pair for the following year.
- 11. All returning bucket/bottle calves will be shown with all other market individual calves.

MARKET BEEF PENS

Class No. 20290 - Pen-Of-3 Fed Cattle

- 1. Each 4-H or FFA member may exhibit 1 pen of three fed cattle.
- 2. Each pen-of-3 will be shown as a group. They will be placed in blue, red, and white groups. Grade, cut ability, yield, and uniformity will be the main points considered.
- 3. Cattle should be carrying enough finish & weight to be ready for market.
- 4. They do not need to be broke to lead.
- 5. No watering down of pen-of-three cattle in their pens is allowed.

BREEDING HEIFERS

Class No. 20100 - Beef Breeding Heifers

1. All 4-H Breeding Beef must be ID'd on 4-H Online or with their FFA Advisor by May 15th. Heifers weighed in and designated as market beef may be shown as either market or breeding beef, but not both. Breeding heifers MUST identify a tattoo number as a primary identification. ID's must be identified by May 15th on 4-H online. Breeding heifers MUST have an ear tag as secondary identification. The ear tag must be a 4-H hanging ear tag where numbers are legible to read and is clear when identifying the tag. (ex: a 4-H Tag, include all numbers). This can be purchased at the Extension Office.

Example of hanging ear tag:



- 2. Breeding heifers must be breeding age and must be born between January 1st, 2023 and June 1st, 2023. A birthdate is required when identifying the animal in 4-H Online or with FFA Advisor. Any breed or crossbred is eligible.
- 3. Up to two (2) heifers may be shown by each exhibitor.
- 4. **ALL BREEDING HEIFERS** will be weighed in for check-in and show purposes. Classes will be broken by weight.
- 5. Heifers must be broke to lead and shown at halter with grooming.
- 6. All heifers will be judged from the standpoint of type, quality, and conformation, with future usefulness as a breeding cow considered.
- 7. Exhibitors need to enter the following information when they enter their breeding heifer for the fair:
 - 1) Sire Breed/Identification
 - 2) Dam Breed/Identification
 - 3) Ear Tag Number
 - 4) Tattoo Number
- 8. Heifers shown in this class **cannot** be shown in the market beef class.

Class No. 20160 - Cow/Calf Pair (1st Year Beef Heifer & Calf)

- 1. All 4-H Cow/Calves must be ID'd by May 15th. If the calf has not been born by this time, just leave the date of birth for calf blank and call the Extension Office to let them know when the calf is born.
- 2. The heifer (mother) must have been shown as a **breeding heifer** at the Emmet County Fair the previous year by the same 4-H/FFA member or by an immediate family member upon graduation.
- 3. The first-year breeding heifer and her calf will be shown as a pair.
- 4. The pair will be judged on type, quality, conformations, and future usefulness of the calf as a beef animal (breeding and feeding).
- 5. Exhibitors need to enter the following information when they enter their cow/calf pair for the fair:
 - 1) Birthdate of Calf
 - 2) Sire Breed/Identification of Heifer
 - 3) Dam Breed/Identification of Heifer
- 6. 1st year heifers (cow) shown here cannot be shown in any other division.
- 7. Cow/calf pairs will be stalled in pens.
- 8. Cow/Calf pairs will not be weighed in. Let the extension staff know at weigh in you have a cow/calf pair.
- 9. **NO** market heifers shown year prior can come back as a cow/calf pair.

PROSPECT CALF

Class No. 20270 - Prospect Calf

- 1. A maximum of 6 head can be identified in 4-H Online by July 8th.
 - 1) If you are planning to show at Clay County Fair or Iowa State Fair, check their deadlines for enrollment.
 - 2) Calves must be born between January 1st and May 15th of the current year.
 - 3) Calves must be identified with an ear tag.
- 2. Exhibitors are limited to TWO entries in this class

- 1) If an exhibitor has a cow/calf entry, they can pull the calf from the pen to exhibit as a prospect calf.
- 2) No bucket/bottle calves are allowed to enter into this class.
- 3. If numbers warrant, the class will be split by sex and birthdate -- heifers will show in the first class, bulls and steers will show together in the second class.
- 4. All prospect calves will only be able to arrive to the fairgrounds on Saturday morning and must leave the fairgrounds Saturday following the show. If the calf is a part of cow/calf entry, it must check in on Wednesday and stay for the duration of the fair.
- 5. Any kind of advertisement of sale on any prospect calf will NOT be allowed at any time during the fair. The animal(s) will be disqualified.

4-H BUCKET/BOTTLE CALF

Class No. 20300 - Bucket/Bottle Calf

- 1. Emmet County 4-H'er in grades 4-6 may exhibit in this class.
- 2. Calves (newborn, orphan, steer or heifer beef, crossbred or dairy) must be born between February 1 and May 15. Calves must be tagged with a 4-H tag and identified by May 15th. A 4-H'er can identify up to 3 calves, but only show 1.
- 3. The calf must be purchased and in possession of the exhibitor by May 15. Calf must be bucket/bottle fed (no nursing). Horns cannot be over 1 inch long.
- 4. Judging will be based on the 4-H'ers knowledge of the calf's health and condition, completed record, general health of calf, etc. Confirmation and quality of calf is NOT to be considered.
- 5. Washing is allowed—No trimming or clipping is allowed or the animal/exhibitor will be disqualified.
- 6. The class will be divided, depending on numbers of entries, at the discretion of the beef committee.
- 7. Calves must be on the fairgrounds by 9:00 AM on Thursday.
- 8. Bucket/Bottle calves may not go through the livestock auction and are not eligible for the showmanship contest.

BEEF SHOWMANSHIP

Class No. 20901 - Junior Beef Showmanship (grades 4-6)

Class No. 20902 - Intermediate Beef Showmanship (grades 7-8)

Class No. 20903 - Senior Beef Showmanship (grades 9-12)

- 1. Showmanship will be held on Friday.
- 2. Beef showmanship participants must enter by July 8th in Fair Entry, so that classes can be split.

Swine Department

Swine Committee: Trevor Enerson, Keith Richard, Amy Hoyer, Tyson Enerson, Evan Klingbeil, and Nicole Tifft

Show Order: 1) Market Pens of 3 Swine, 2) Showmanship, 3) Breeding Gilts, 5) Purebred Market Swine

- You must follow the stall assignment until after weigh in. Then after there could be a possibility of changes. There will also be NO TACK PENS until after weigh in. Final decisions are made by Swine Committee.
- 2. A maximum of 40 market and breeding swine may be identified (by May 15th) from which to select fair entries. All swine must be identified with a USDA ear tag and MUST have ear notches.

- 3. All swine exhibitors must choose where their pigs will be going at the conclusion of the fair: on the truck, home or barn address (if different from home address).
- 4. Each exhibitor must turn in their swine disclosure form at the Barn Meeting on Thursday.
- 5. The fair will be non-terminal for swine (unless health issues arise). However, due to health concerns, pigs are encouraged to be harvested.
 - 1) The swine committee reserves the right to ship any or all swine at any time if health issues arise.
- 6. To prevent possible problems with erysipelas, all swine coming to the Emmet County Fair must be vaccinated using a straight Erysipelas vaccine at the following times:
 - 1. Required: 1st shot at 40 lbs. or above,
 - 2. Optional shot: 2-3 weeks after 1st shot,
 - 3. **Required:** Between 45 & 21 days prior to fair. Recommended that veterinarian administer the last erysipelas shot.
 - 4. THERE IS TO BE NO USE OF PAYLEAN (RACTOPAMINE) USED IN SWINE BEING SENT ON THE TRUCK
 - i. You will be required to sign an affidavit saying you did not feed your swine Paylean. For more information please see; https://www.extension.iastate.edu/news/learn-more-about-ractopamine-and-swine When entering for the fair online, you must enter in the vaccine type, lot #, expiration date, as well as date shots were given.
- 7. Premise ID's are **REQUIRED** make sure to obtain one and enter into Fair Entry. Health certificates verified by the official fair veterinarian may be required prior to taking your pigs home.

ULTRASOUND

Class No. 26250 - Ultrasound

- 1. Purebred Market Swine, Crossbred Market Swine, and Breeding Swine are eligible to join this contest.
- 2. Each exhibitor is REQUIRED to enter 1 pig into this class.
- 3. The purpose of this class is to have the youth get a better understanding of what the loin eye area is, and what is calculated during the ultrasound.

MARKET SWINE

Class No. 26200 - Purebred & Crossbred Market Swine

- 1. All market swine exhibited must be individually ear tagged as indicated and entered at http://v2.4honline.com (4-H projects) or ID'd with your FFA Advisor (FFA projects) by May 15th.
- 2. Classes will be provided for crossbred and purebred market pigs. If fewer than five head are entered for any given purebred class those entries will be shown in the Other Breeds Class. The following divisions will select a champion; crossbred market gilt, purebred market hog and crossbred market barrow. These three division winners will compete for champion in the Market Swine Division.

CLASS (This is not the show order)

- Berkshire Market Pigs (gilts & barrows)
- Chester White Market Pigs (gilts & barrows)
- Duroc Market Pigs (gilts & barrows)
- Hampshire Market Pigs (gilts & barrows)
- Landrace Market Pigs (gilts & barrows)

- 1. All sexually intact sheep/goats must have a scrapie tag in their ear and must list this tag number on their weigh-in form or when identifying the animal. Call the USDA at 866-873-2824 to obtain a Family Farm Identification Number.
- 2. All lambs/goats must have four feet on the floor in the show ring at all times. Lifting feet off the ground or placing on any support or altered ring surface is not acceptable. Exhibitors will receive one warning if they are found lifting or slapping lambs/goats. Second offenses will result in automatic exhibitor disqualification from the show.

- 3. All sheep/goats must be weighed in at the Emmet County Fair on Wednesday. Animals MUST BE penned without blankets on. No blankets or coverings such as hoods and leggings are allowed until animals are weighed-in and inspected by the fair veterinarian.
- 4. Each exhibitor must turn in their sheep/goat disclosure form/s at the Barn Meeting on Wednesday.
- 5. There will be no stalling of sheep/goats until after weigh-in. You must follow the stall assignment until after weigh in. There will also be **NO TACK PENS** until after weigh in.
- 6. No cable halters are allowed.
- 7. No fitting of breeding and market goats. (Shampooing of goats is allowed, but use of conditioner is not allowed)
- 8. Any evidence of club lamb fungus, ringworm, draining abscesses, foot rot, sore mouth, or any other contagious disease will eliminate the animal from the show at the Official Fair Vets Discretion. Animals will be subject to inspection at the trailer and a secondary inspection at the scale during weigh-in. Animals will be subject to further inspection while at the fairgrounds.

MARKET SHEEP

- 7. All sheep must be slick shorn prior to weigh-in. There will be no complete shearing at the fairgrounds. Grooming is allowed.
- 8. Market sheep cannot be shown in Breeding Ewe Classes.

- 6. Goats must have kid teeth in normal position.
 - a. Any meat goat with no kid teeth will be disqualified
- 7. Goats must be broke to lead with a halter or collar and short lead when showing, body clipped with 3/8" length of hair or less, and hooves cleaned and trimmed prior to arrival on the fairgrounds.
- 8. Exhibitors will be required to have horns disbudded, dehorned or tipped blunt on all market wethers before arrival on the fairgrounds. Removal of horns on Fairgrounds is NOT permitted.
- 9. Goats must be shown without coat compound, oils, paints, powders, etc.
- 10. All market meat goats weighed-in at the fair will be in the rate-of-gain contest.
- 11. Market meat goats cannot be shown in the Breeding Meat Goat classes.

- 1. 4-H members must have horse or pony projects ID'ed in 4-H Online and FFA with FFA Advisor by May 15th. Photos are required to be downloaded. All equine must be identified as outlined in "Iowa 4-H Livestock Show Requirements" 4-H 202 available at: https://store.extension.iastate.edu/product/194
 - 1) A horse can be identified by more than one 4-H member (immediate sibling or step-sibling only), but cannot be identified as 4-H under one sibling and FFA under another sibling.
 - i. The same animal will only be allowed to show in a class ONCE at the fair– for example, a 5th grade 4-H'er cannot show a horse in barrels, and the 8th grade sibling show the same horse in barrels; however, the other sibling could show that same horse in pole bending for example.
- 2. A lease horse can show at Emmet County Fair, and WILL be able to be shown at Iowa State Fair, for additional state fair rules on this, please see "Iowa 4-H Livestock Show Requirements" 4-H 202 available at: https://store.extension.iastate.edu/product/194
- 3. A maximum of 4 horses/ponies may be entered, with a maximum of 2 riding horses.
- 4. Exhibitors may enter in an unlimited number of classes.
 - 1) A rider may exhibit only once in each class. Example: once per Western Pleasure, Barrel Race, etc. Exception: Unless prior approval from the Horse Committee.
- 5. There will be Grand & Reserve Champions in Junior & Senior Divisions on only one rider/horse combination. Points will be given to the one rider/horse combination as follows: 1st receives five (5) points, 2nd receives four (4) points, and so on through 5th place. Points will be awarded for blue ribbons only.
 - 1. 4-H'ers wanting to compete for Grand and Reserve Champion Horseman must compete in:
 - > Jr. or Sr. Trail Class and Jr. or Sr. Showmanship
 - 2. Plus, select 2 of the 8 following classes for point totals:

Jr. or Sr. English Equitation

Thus, Champions will be based on scores from four classes - two mandatory and two selected by the 4-H'er. The exhibitor must choose which classes they will be participating in for points and which horse

they will be using when they enter for the fair by July 8th. Exhibitors will be divided into two age divisions (junior/senior) if there are at least 5 exhibitors per age division. The decision about splitting into divisions will be made after the July 8th entry deadline.

- Seniors just completed 8th—12th Grade
- 6. If the space is available, all horses are required to be housed at the fairgrounds.
 - 1) Horses are to be stalled at all times other than bathing, clipping, and for exercise time in designated areas only (horse barn, wash rack, and arena area).
 - 2) Each exhibitor is responsible for keeping his/her stalls clean and the aisles swept out.
 - 3) Each exhibitor must feed & water their horse while on the grounds.
- 7. Absolutely no riding of horses in the barn. When a horse is ridden, a bridle must be used for safety. Horses must be ridden at walk from the barn to the show area. Helmets must be worn at all times.
- 8. Only the exhibitor, their family members, or horse project leaders may ride or handle an exhibitor's horse at any time during the fair. If anyone else rides/handles the horse, the horse & exhibitor will be disqualified from the show and premiums will not be paid. The only exception is if the safety of horse/4-H'er is in question.
- 9. All horses showing in the 4-H/FFA show on Wednesday/Thursday are required to be vaccinated for Eastern and Western Sleeping Sickness, Tetanus, and Influenza. There will be an affidavit to sign to turn in at the horse barn meeting.
- 10. We will allow the judge to determine if soundness is an issue.
- 11. Any horse that is unmanageable (bucks, kicks, rears, runs off) will be excused from the ring. A horse will be allowed 3 attempts to enter the ring safely. After that the horse/pony and rider will be excused from the class.
- 12. EXHIBITOR APPAREL See your "Rules and Regulations for Equine Shows in Iowa" 4-H 511C book or online at: https://www.extension.iastate.edu/equine/horse-and-pony-4-h-youth-development Western p. 22, p. 58; English p. 22, p. 38-39; Timed events p. 121. Zippered shirts are now allowed.
 - 1) All 4-H youth participating in any riding classes must wear American Society of Testing Materials (ASTM) and Safety Engineering Institute (SEI) approved headgear with chin strap and properly fitted harness while mounted and riding, including warm up.
 - 2) For Timed Events ONLY, exhibitors may choose to wear their 4-H t-shirt.
- 13. Awards will be given for Senior Grand Champion Horseman; Senior Reserve Champion Horseman; Junior Grand Champion Horseman; and Junior Reserve Champion Horseman.
- 14. General Livestock Rules and "Rules and Regulations for Equine Shows in Iowa" 4-H 511C govern all exhibits in this department. 4-H 511C (see website above in #18).
- 15. Any rules not followed will result in disqualification from all recognitions, awards, and premiums. If this would involve Grand or Reserve Champions, the placings will be moved to the next in line as determined by point totals and approved by the horse committee.
- 16. The fair veterinarian must inspect and give written consent for any horse to leave before checkout time. If an exhibitor needs to take their horse before 5:00 pm on Sunday in order to participate in another horse show, they must ask the Emmet County Fair Board in writing by July 8th.

HORSE PRACTICE RULES

- Horses must have all shots/vaccinations completed by May 15th. No horses will be allowed at practice without these shots/vaccinations.
- All riders must wear ASTM/SEI-approved helmets when riding in the arena and on the Fairgrounds during designated 4-H Horse Practice times. There are no exceptions to this.
- Only currently enrolled 4-H members (and screened 4-H volunteers who are leading practices) may be riding in the arena and in the area immediately surrounding the arena during designated 4-H Horse Practice times.
- Riders must wear full-length pants and appropriate riding boots during 4-H Horse Practices.
- Riders are expected to be courteous and follow ring etiquette while in the arena. This includes:
 - Enter and exit the ring at a walk and begin riding to the right.
 - All riders must work in the same direction unless otherwise instructed by the leaders.
 - Riders must keep at least one horse's length between them and other horses, even when passing.
 - Always ride the rail and pass to the inside of the ring, announcing when you intend to pass.
 - Do not cut off another horse and rider.
 - Mount and dismount in the center, not on the rail.
 - Keep all gates closed while the arena is in use.
 - Be respectful of other riders and their abilities and if they are having problems with their horse, please give them extra space.
 - There should be no loose horses in the arena while others are riding
 - See "4-H Rule and Regulations for Equine Shows in Iowa" for 4-H rules regarding acceptable tack.
- Spectators should stand outside the arena, not alongside the rail or in the middle of the arena.
- No dogs in the arena with horses and riders.
- In an Emergency, Stop: If a rider falls off and/or a horse gets loose, all riders must stop and if asked, dismount.
- Help put away any equipment (barrels, standing poles, ground poles, cones, etc.) at the end of practices
- 4-H members may use the arena on their own time unless there is another scheduled event, such as Saddle Club, rodeos, etc. When using the arena at a time other than an officially scheduled 4-H Horse Practice, you are riding "at your own risk" and the 4-H Program is not responsible for any injuries, losses, etc. incurred during that time.

- 1. All rabbits and poultry must be checked-in at the mandatory check-in. If exhibitors have not checked in rabbits/poultry by designated time, they will not be allowed to exhibit.
- 2. Exhibitors need to be sure rabbits & poultry have water at all times—it is recommended for poultry that you cut a 1/2 gallon milk/juice jug and leave the handle on to tie/zip tie to the side of the cage. Water containers must be attached to cages to prevent spilling. Animals need to be given water at least 2-3 times a day—if you are not going to be at the fair for this, please ask someone to help you with this.

- Exhibitors should refresh bedding as needed—extra bedding will be available in the Fair Board office.
 Exhibitors need to remove all bedding from under cages and make sure cages are clean by 10:00 PM Sunday evening.
- 4. Exhibitors participating in the 4-H/FFA Market Livestock Premium Auction with a market rabbit or market poultry need to be in the east swine barn (behind podium in show barn) with their animals in plenty of time prior to their turn or they will be scratched. See other auction requirements on page 7.
- 5. For classes of 5 or more, a champion & reserve champion in class will be awarded.
- 6. Exhibitors **MUST** follow substitute showman rules as stated for rule #13 in the Livestock Exhibits section of the fair book.
- 7. Exhibitors that bring poultry and/or rabbits to the fair should consider bringing their own padlocks or zipties to secure doors on cages for safety and security.

- 4. Testing for U.S. Pullorum-Typhoid clean or equivalent flock will be done. The judge will be informed if the pullorum testing was conducted at check-in of the fair.

EMMET COUNTY ONLY MYSTERY POULTRY CONTEST

Class No. 24601 – Junior Exhibitor Mystery Poultry (grades 4-8)
Class No. 24602 – Senior Exhibitor Mystery Poultry (grades 9-12)

- 1. The purpose of this contest is to learn about raising and caring for poultry during the different life stages of the bird. Exhibitors will not know the breed of the bird when they receive it. Exhibitors will work to learn about the breed of the bird, what the bird's purpose is (eggs, meat, etc.), and how to care for the bird (housing, feed, etc.). Exhibitors will create a minimum of one goal for their project and record the animal care & management practices they do throughout the project.
- 2. Mystery Poultry birds will be sold to 4-H/FFA members who would like to participate in this contest. Exhibitors MUST ORDER their birds through the Extension Office ONLY. Exhibitors must place an order with the Extension Office by the deadline. They will be distributed on a date to be announced. Minimum order will be as follows:
 - a. Single exhibitor: Minimum of 5 birds
 - b. Two exhibitors from a family: Minimum of 8 birds
 - c. Three exhibitors from a family: Minimum of 10 birds
 - d. Four or more exhibitors from a family: Please contact the Extension Office
- 3. Exhibitors will receive mystery chicks from the Extension Office and use the Mystery Bird Workbook for their project. The Mystery Bird Workbook is required to be filled out for the fair. Exhibitors will be given the book when they receive their mystery birds. The workbook will track the progress of the project.
- 4. An exhibitor is limited to entering one pen (one bird) for the class.
- 5. Exhibitors will enter animals on www.fairentry.com under the Mystery Poultry class. The bird selected for the Mystery Poultry Contest cannot be exhibited in another class, however birds not selected for the contest may be entered in Class No. 24004 One Pullet or Class No. 24410 Production Pullets.
- 6. During the fair, exhibitors will bring their mystery bird and show them during the mystery poultry contest, along with their workbook.
- 7. The judge will talk with each exhibitor about their mystery bird. Exhibitors should be expected to answer the breed of the bird, how they determined the breed of the bird, how they cared for the bird, and their project goal and reflection of goal.
- 8. Exhibitors will receive a blue, red, or white ribbon. Judging will be based on the knowledge of caring, handling, and feeding of the bird and completion of the exhibitor's goal(s) from the workbook. There will be an overall Grand Champion and Reserve Grand Champion awarded for this contest.
- 9. Mystery poultry birds cannot go through the premium auction.

<u>PETS</u>

- 1. A 4-H member must have ID'd their pet by July 1st and FFA member must ID with their instructor.
- 2. An exhibitor is limited to entering two total pets.
- 3. Animals who are entered in any other class/show in the Emmet County Fair are NOT eligible to be entered and shown in the Pet Show.
- 4. Pets can include but are not limited to alpacas, llamas, amphibians, reptiles, fish, birds, cats, dogs (not in Dog Obedience), gerbils, guinea pigs, hamsters, rabbits (not in Rabbit Show), rodents, and other pets.

- 5. Cats and dogs must have rabies vaccination information (vaccination number and date) entered when identifying animals or turned into the Extension Office July 1st.
- 6. All exhibitors must be responsible for their pet at all times on fairgrounds.
- 7. All pets should come on a leash or in a box, cage or bowl. (Cats and Dogs should have a collar and leash.)
- 8. Judging will take place on Wednesday, along with the open class pet show for youth in grades K-3.
 - 1) Judging will be based on (as appropriate for that kind of pet) health, nutrition, environment, grooming, behavior/handling and exhibitors dress and knowledge of caring, handling, and feeding their pet.
 - 2) Exhibitors and their animals will be judged against other members in their age division, and an award given to First Place handler and pet in each of the two age divisions. First-place winners will then compete for Best of Show. The Best of Show handler and pet will walk in the Parade of Champions on Sunday.
 - 3) **Ribbons** will be awarded as follows:

i.	Blue	80-100 points
ii.	Red	70-79 ½ points
iii.	White	69 ½ points of lower

9. Members need to bring animals in the pet show to the location of the show on the fairgrounds by 12:45 PM on Wednesday. Pets will not be allowed to stay at the fairgrounds. They are to be returned home after the conclusion of the pet show.

DOG

1. ELIGIBILITY:

- a. 4-H'ers must ID their dog at: https://v2.4honline.com by May 15th.
 - i. A dog can be identified by more than one 4-H member (immediate sibling or step-sibling only), but cannot be identified as 4-H under one sibling and FFA under another Sibling.
- b. You MUST enter all dog entries for the Fair in the correct class at fairentry.com by the deadline advertised each year.
- c. All exhibitors must enter and exhibit their dog in an obedience class in order to participate in any other division.
- d. Handlers are limited to 2 dog entries.
- e. A \$5 program fee must be paid to the extension office by the first practice with the dog.
- f. Vaccination certification must be turned in to the extension office by the first practice with the dog.
- g. The dog must be at least 6 months old by the time of the first practice with the dog.
- h. Fair entries in this division are open to purebred or mixed breed dogs which may or may not be owned by the exhibitor. In all cases, the dog is to have been trained by the exhibitor.
- i. Titled dogs may be entered only in classes above their title.

2. HEALTH REQUIREMENTS:

- a. Dogs must have a health certificate showing the dog has been vaccinated for rabies with in the past 3 years. It is recommended the dog also has had either a temporary or permanent distemper immunization. Dogs must be vaccinated for parvo virus.
- b. Bitches in heat may not be shown at the time of the fair.

3. DOG PRACTICE RULES:

- a. For Junior or Intermediate 4-H members in their first year in the dog program, a parent or guardian is REQUIRED to attend the first three practices with the 4-H'er and their dog.
- b. The Dog Committee can request any observer be out of the line-of-sight of a dog if their presence is causing a distraction during training.
- c. Handlers must attend at least 50% of scheduled dog obedience meetings to be eligible for exhibition at the fair in the dog show. The first meeting of the year (the Yearly Informational Meeting) & the first 4 practices in April are HIGHLY ENCOURAGED to first year dog program members.
- d. If a dog shows aggression towards another dog or handler at practices, the dog is dismissed for that practice and the possibility of attending additional practices at the discretion of the Dog Committee. The handler may continue in the program, but may be required to use a different dog.
- e. Dogs must have a collar and leash on at all times, unless otherwise specified by the leaders. No shock collars, gentle leaders, or harnesses will be allowed. Leashes shall be 6-feet in length and can be nylon, leather, or cotton webbing. All dogs should have a properly fitted training chain for obedience and rally, a show lead for handling, and a regular collar in agility, unless otherwise specified by the leaders.
- f. Should a dog fight break out, please keep your hands away from both dogs. Try to pull your dog away from the altercation by tugging on the leash. Yell for HELP from an instructor.
- g. Treats will be used in the training process during practices ONLY AS NEEDED and at the leaders' discretion. Members must bring their own treats to do this, and ONLY under the direct supervision of a leader. Treats are not permitted in the show ring at Fair during obedience, rally, or agility. Treats are permitted in the show ring during handling. We will work, however, to utilize positive reinforcement, namely attention and praise, as we train our canine friends.
- h. Use of cell phones is not permitted during practices, and please keep your valuables at home, as ISU Extension and your instructors are not responsible for lost or damaged property.
- i. Let an instructor know if your dog has aggressive tendencies or is scared of other dogs, frightened of people, not feeling well, or not acting normally. We want to avoid dog fights, injuries to fellow members of 4-H, and the spread of illness.
- j. If you feel your dog is strong enough to pull you around, please bring a pair of gloves to save your hands!

k. If your dog urinates or defecates in practice areas, you are expected to clean up after it. Clean-up materials will be provided by the instructors. To minimize the chance, members should arrive to class 10-15 minutes early, if possible, so they can walk around and do their business before class starts.

4. EXHIBITOR CONDUCT:

a. Members are expected to be courteous to each other and to the other dogs. 4-H members shall not use harsh or excessive corrections (verbal or physical) at any time. Continuing display of this after a warning by the leaders is considered grounds for removal from the program.

5. EQUIPMENT:

- a. Dog exhibitors must provide their own leashes, grooming equipment, pet crates, water bowl, and food. While in the show ring exhibitors must use properly fitted collars and leashes (as described above) appropriate for their dog's breed and level of training.
- b. The handler must use program equipment only after instruction has been given and only when supervised by an instructor or senior 4-H member of the dog program.
- c. Jumps will be measured at the dog's shoulder height (withers). Members need to know the withers height of their dog.

6. DRESS CODE:

- a. Members are required to wear closed-toe shoes or boots for practices and during the show. No sandals or slip-on shoes, heelless, or high heeled shoes are allowed.
- b. An official 4-H or FFA t-shirt with jeans or pants is required during the dog show.

7. DOG SHOW RULES:

- a. HOUSING Housing cannot be provided on the fairgrounds for dog entries; thus, county exhibitors should plan to arrive at the location of the show on the fairgrounds 15 minutes before the show starts.
- b. CHECK-IN PROCEDURES Handlers may bring a rug, blanket, etc. for their dog to sit on when not "showing" in a class—to help keep the dog clean and comfortable.

c. SHOW RING PROCEDURES:

- i. Any dog who displays aggressive behavior during the Dog Show at the Emmet County Fair will be immediately excused from the remainder of the show.
- ii. All dogs must be on a leash at all times outside the show ring. Dogs are not allowed anywhere on the Emmet County Fairgrounds during the Fair, except for in and around the building in which the Dog Show will be held, as well as in the designated agility area. Exhibitors shall be ready with their dog when their class is called.
- iii. Dogs are to be shown by the 4-H/FFA member only, with no substitute showman permitted.
- iv. 4-H rules are based on AKC guidelines for judging.

- v. Grand Champion and Reserve Grand Champion obedience and agility will be selected based on the score sheets point system.
- vi. The Best of Show Dog will be determined from a combination of the obedience, handling, agility, and rally scores for the same dog.

DOG OBEDIENCE

Division Rules:

- 1. If a dog/exhibitor achieved a qualifying score in a class at the previous year's Emmet County Fair, he/she must move up to the next class. Exceptions of moving from a level "B" class to the next higher level "A" class can be made at the discretion of the Dog Committee. Handlers may choose to skip levels based on their dog's performance, upon approval of the Dog Committee.
- 2. Exhibitors are limited to one entry per class in this division, except class 30180: Graduate Novice B
- 3. Qualifying score = 170 points or above.

Note: The number of years of experience for either exhibitor or dog incudes participation at a county fair and/or State Fair dog show and includes the current 4-H year.

DOG RALLY

Division Rules:

- 1. The exhibitor is limited to one entry per class in this division, except Rally Advanced, where two entries are allowed.
- 2. Rally classes are open to dogs in the second year or beyond of obedience training.
- 3. Dogs must enter and leave the ring on leash. An exhibitor leaving the ring without the dog on a leash will have major points deducted from their score.
- 4. AKC guidelines and rally signs will be used as judging guidelines for these rally classes. Rally courses will not be released until the day of the show. Exhibitors are to know the signs in their appropriate class level prior to entering the class.

- 5. Exhibitors will walk the course without their dog prior to showing. The judge will be available at walk-through to answer any questions.
- A dog who has received a Rally Novice title in any sanctioned show such as AKC (American Kennel Club) or UKC (United Kennel Club) must compete in Rally Intermediate or Rally Advanced.

Ribbons will be awarded as follows:

Class No. 30310 – Rally Novice A

<u>For exhibitor/dog combinations which have not previously competed in any rally class & are in their first year of rally training.</u> All exercises are performed on leash. There will be between 10-15 stations (start and finish not included) with a minimum of three and a maximum of five stationary exercises. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise. AKC Novice level signs will be used.

Class No. 30320 – Rally Novice B

For exhibitor/dog combinations which have competed in any rally class & are in their 2nd or 3rd year of rally training. All exercises are performed on leash. There will be between 10-15 stations (start and finish not included) with a minimum of three and 36 a maximum of five stationary exercises. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise. AKC Novice level signs will be used.

Class No. 30330 – Rally Intermediate

For exhibitor/dog combinations which have competed in any rally class and are in their 4th year of rally training or more or for a dog who has earned any Rally Novice title (AKC, UKC, etc). Exhibitor/dog combinations are limited to 2 years in this class. All exercises are performed on leash. There will be between 12-17 stations (start and finish not included) with a minimum of three and a maximum of seven stationary exercises. Intermediate courses will have a minimum of three Advanced level stations. There are no jumps in this class. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise. AKC Intermediate level signs will be used.

Class No. 30340 - Rally Advanced

For exhibitor/dog combinations which have competed in a rally class with 5 or more years in rally training or for dog who has earned any Rally Intermediate title (AKC, UKC, etc.). There is no limit on the number of years an exhibitor/dog combination can compete in this class. All exercises are performed OFF leash. There will be between 12-17 stations (start and finish not included) with a minimum of three and a maximum of seven stationary exercises. Courses will have a minimum of three advanced level stations plus one required jump. Exhibitors are allowed to pat their legs, clap their hands, or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise. AKC Advanced level signs will be used.

DOG AGILITY

Division Rules:

- 1. The exhibitor is limited to one entry per class in this division.
- 2. Scoring for all agility classes will be based on performance and course time.

- 3. Agility classes will use a variety of equipment which may include any of the following: 12' dog walk, 9' A-frame, 12' teeter, single jumps, double jumps, triple jumps, weave poles, panel jumps, broad jump, open tunnel, and pause table.
- 4. No training/chain collars (choke chains) allowed.

Ribbons will be awarded as follows:

Blue70-100 pointsRed60-69 % pointsWhite59 % points or lower

Class No. 30191 – Sub-Novice Agility

For exhibitors and dogs who are both in their first year of training; for exhibitors in their first year with a 2^{nd} year dog; for exhibitors in their 2nd year with a 1st year dog. All dogs will follow a course on leash.

Class No. 30192 – Novice Agility

For exhibitors in their 2nd year with a dog in its 2nd year of training; for exhibitors with 3 or more years of training with a dog in its 1st year; for exhibitors in their 1st year with a dog that has 3 or more years of training. Leash is optional.

Class No. 30193 – Graduate Novice Agility

For exhibitors with 2 or more years of training with a dog with 3 or more years of training or that is titled in agility. Dogs will follow course off leash.

DOG COSTUME

Division Rules:

- 1. The exhibitor is limited to one entry in this division.
- 2. Judging will be based on the costumes for the exhibitor/dog teams, and effort put forth to create a homemade costume will be taken into consideration. Exhibitors will be awarded prizes for 1st, 2nd, and 3rd places.
- 3. Placings in this class will not be used toward point total for Best of Show.
- 4. No ribbons or premium money will be awarded for this division.

Class No. 30410 - Costume

For exhibitor/dog teams that have dressed in costume and have followed a theme.

- 1. Entries are limited to members of Emmet County 4-H.
- 2. Division categories are determined as follows:

 - 2) Intermediate completed 7th or 8th grades
 - 3) Senior completed 9th, 10th, 11th, or 12th grades
- 3. All static exhibit entries will be made through the www.fairentry.com website by 4 PM on July 15th. Entries NOT made in Fair Entry are NOT allowed to be checked in on judging day.

- 8. After a 4-H'er has had 5 exhibits judged by one judge, they must go back to the waiting area and wait for their turn to be judged again.
- 9. Exhibits can be done by an individual, team, or club and may represent all or part of the learning in the project or program. A team is two or more members. Teams can be a combination of 4-H members from other clubs. Premiums will be paid to each member of the team. One premium will be paid for a club exhibit.
- 10. A 4-H member can be part of a maximum of three team/club exhibits.
- 11. All exhibits should be the work of active 4-H members and must have been made or completed in the current year (since the date the previous fair ended). Exhibits may be made for someone other than the exhibitor. Eligible exhibits are an outgrowth of work done as a planned part of the 4-H'ers participation in 4-H projects or programs. If a 4-H'er has set a goal(s) that can be accomplished by both a classroom assignment and an outgrowth of a 4-H project goal, that's okay. The intent is that a predetermined goal has been set. Example: Class assignment was to design a banner. 4-H goal: to make a banner for use in exhibitor's room. The 4-H'er must realize that the evaluation criteria and exhibit guidelines for each opportunity will be different and should prepare the required support information accordingly.
- 12. The 4-H member's goal & applicable exhibit standards will form the basis of the evaluation process. Evaluation criteria will include demonstrated learning, workmanship & techniques, and general appearance & design. Refer to exhibit class evaluation rubrics for detailed evaluation criteria in each class. Rubrics are located on each 4-H project page at: http://www.extension.iastate.edu/4h/projects.
- 13. A written explanation, audio recording, or video recording is to be included as part of each exhibit.

 Audio or video should not be longer than 10 minutes and must be uploaded to YouTube. The exhibitor should respond briefly to the following questions about the exhibit:
 - 1) What did you plan to learn or do? (What was your exhibit goal(s)?)
 - 2) What steps did you take to learn or do this?
 - 3) What were the most important things you learned?

Check for additional requirements for entries in clothing and fashion, food & nutrition, photography, visual arts, home improvement, sewing classes, and 4-H poster communication.

- 14. Exhibits might be, but are not limited to; an actual product, poster, display box, report, notebook, model, DVD, PowerPoint presentation, etc.
- 15. If the exhibitor chooses a display to illustrate what was learned, the following size requirements must be followed:
 - 1) Posters may not exceed 24 inches x 36 inches in size. (See Classes 10490 and 10530 for smaller requirements.)
 - 2) Chart boards, graph boards, project presentation boards, model displays, etc., may not exceed 48 inches x 48 inches in size. Maximum size is determined by measuring the flat (unfolded) dimensions.
 - 3) Display boxes may not exceed 28 inches x 22 inches in height or width and 12 inches in depth. Exhibits that do not comply with the class description, size guidelines, copyright restrictions, safety, and approved methods will be disqualified and not put on public display.
- 16. Endangered, threatened, and "special concern" plants and animals (including insects), or songbird feathers and nests may NOT be used in any exhibit. Game animals legally taken are acceptable, with the exception of any hogs (Sus species) per State Law. Live specimens of noxious weeds or invasive species

are NOT permitted in any exhibit. Dried specimens are acceptable to use in exhibits, however viable noxious/invasive plan seeds shall not be included. (Links to specific information below)

- 17. Copyrighted materials and designs may not be used in a 4-H exhibit that is presented as original work by the exhibitor. Exhibitors must include permission from the copyright holder/owner when using copyrighted materials. Exhibitors must give proper credit to the original source of all materials/designs used in exhibits. (See special rules for Visual Arts and general copyright information for 4-H'ers.)
- 18. All exhibits, activities, and programs must represent appropriate safety procedures in the development of the exhibit and during the evaluation process. This includes static exhibits and activities revolving around the communications program.
- 19. It is expected that you wear a 4-H shirt while being judged.
- 20. There will be no use of phones or smart watches by exhibitors while in the judging area, not including the waiting area.
- 21. Conference judging is encouraged. If the 4-H'er is unable to be in attendance, the exhibits will be set back for a judge to evaluate at their convenience and written comments will be recorded.
- 22. Parents, other adults or youth not assisting judges will not be allowed by judging tables and must remain in the "waiting area".
- 23. If any special equipment (TV, DVD Player, Computer, CD Player, etc.) are needed for your exhibit, you must bring it with you on judging day.
- 24. Exhibits will be released on Sunday of the fair after 5:00 p.m. If exhibits are removed before this time, no premiums will be received. There will be a check-out process—each 4-H'er's exhibits must be checked out before leaving.
- 25. Only 4-H members who have completed 5th grade or above are eligible to have exhibits selected for the lowa State Fair. Exception: Group exhibits from an entire club that include 4th grade members are eligible for the lowa State Fair.
- 26. Exhibits selected at the county level to advance to the Iowa State Fair should not be part of a local auction or sold to another individual before the Iowa State Fair.
- 27. Recognition is given to outstanding junior (4th-6th grade) exhibits.
- 28. The County Youth Coordinator resolves questions not covered by general/specific rules. Decisions are final
- 29. The Emmet County Fair Board and/or Emmet County Extension are not responsible for lost, damaged, or stolen items.
- 30. Large 4-H projects chosen for exhibit at the State Fair must be transported by the exhibitor to Des Moines as determined by staff.
- 31. Clothing & Fashion, Home Improvement, & Visual Arts projects fill out Design Elements on goal sheet.
- 32. Premiums: Blue \$5.00; Red \$4.00; White \$3.00.

Animals

Class No. 10110 - Animal Science

An exhibit (other than the animal itself) that shows the learning about a large or small animal including beef, dairy cattle, dairy goats, dogs, horse and pony, meat goats, pets, poultry, rabbits, sheep and swine. Ownership of any animal is not required.

An exhibit that shows learning about keeping animals healthy, animal diseases, animal/human health interaction, or other learning related to Veterinary Science.

Agriculture & Natural Resources

Class No. 10210 - Crop Production

An exhibit that shows learning about the growth, use, and value of field crops, plant growth, soils and soil fertility, or any other learning related to crop production and plant science.

Class No. 10220 – Conservation, Environment, and Sustainability

An exhibit that shows the connections between humans and their environment including energy, energy conservation, stewardship, conservation, creating habitat, etc.

Class No. 10222 - Entomology

Any exhibit (excludes live specimens) that shows learning or is an outgrowth of an entomology or bee project experience. Includes specimen collections and may include products (for example honey) or equipment as part of the display.

Class No. 10224 - Fish and Wildlife

Any exhibit that shows learning about a fish and/or wildlife project or program such as identification, habitats, harvest, taxidermy, etc. Any specimens must have been legally taken and must include information about date and location of harvest, and who the specimen was acquired from if not self-harvested.

Class No. 10226 – Forestry

Any exhibit, including collections that show learning from participation in a forestry project or program.

Class No. 10230 - Horticulture and Plant Science

An exhibit that shows learning about the growth, use, and value of plants, soils, small fruit production, vegetable and flower gardens, plant nutrition, careers, etc. (Garden crops and herbs are exhibited in classes on pages 44-46.)

Class No. 10235 - Home Grounds Improvement

An exhibit that shows learning about landscape plans, selection of landscape plants, ornamental garden features, home yard improvement, storage sheds, careers, etc.

Class No. 10240 - Outdoor Adventures

An exhibit shows learning about backpacking, biking, camping, canoeing, fishing, hiking or outdoor activities.

Class No. 10250 - Safety and Education in Shooting Sports

An exhibit that shows learning about safe and responsible use of firearms and archery equipment or wildlife management. (The exhibit may not include actual firearms; archery equipment allowed if tips are removed from arrows.)

Class No. 10260 - Other Agriculture and Natural Resources

An exhibit that shows learning about agriculture or natural resources and doesn't fit in any classes listed above.

Creative Arts

Class No. 10310 - Music

An exhibit that shows learning about musical performance, composition and arrangements, instruments, musical styles or history. If submitting a video or musical arrangement, it must be uploaded to YouTube.

Class No. 10320 - Photography

An exhibit, either photo(s) or educational display that shows learning about photography from choosing a camera to modifying your photo. Photos only, not video. If more than one photo is exhibited, they must each have a different goal sheet.

Photography Special Rules:

- 1. Photography may be either black and white or color. They may be processed from negatives, slides, or digital cameras and computer manipulation programs. Photographs must have been taken since your county fair of the previous year.
- 2. Photographs should be a minimum of 5 inches by 7 inches. Finished size including mounting/matting of single photographs should not exceed 11 inches by 14 inches. Exception: Panoramic photos must not exceed 11 inches high by 24 inches in length.
- 3. All photographs should be printed on photographic paper and must be mounted and/or matted. Maximum thickness of finished project must not exceed ½ inch thick.
- 4. Mounted photos can be (a) flush-mounted [no board showing] on mounting board or (b) with mount borders [window mat or flat mount directly on board]. Exhibitors may cut their own mounting boards, use ready-cut window mats or have matting done professionally.
 - a. 4-Hers are responsible for design decisions such as border, color, and size.
 - b. Framed photographs (including floating frames) will not be judged.
- 5. Non-mounted photos may be exhibited in clear plastic covering.
- 6. A series is a group of photographs [3 to 5] that are related or tell a step-by-step story. Photographs must be mounted together and numbered in story order or sequence. Finished size of individual photographs in a series must be a minimum of 5 inches by 7 inches and should not exceed 6 inches by 8 inches.
- 7. Edited photos should include a copy of the photo before changes.
- 8. Subject matter of photographs must be in good taste and be appropriate for public display in a 4-H setting.
- 9. Photographs depicting unsafe practices or illegal activities will **not** be displayed.
- 10. Please use the "Photo Exhibit Label" to provide required information for photo exhibits—Pick these up at the Extension Office or print from the website.

Class No. 10340 - Creative Photography

A photographic image that was creatively edited or modified beyond reality in a creative, imaginative, and experimental way to make it more interesting and visually engaging. Could be a composite of multiple overlapped photographs.

Creative Photography Special Rules:

- 1. Photograph/image may be mounted/matted.
- 2. If mounted, photograph/image must be mounted on foam core no smaller than 5 inches in length or larger than 14 inches in length.
- 3. Photograph/image can be digitally created.
- 4. Exhibit must have the most current Photo Exhibit Label on back with required information for photo exhibits. Exhibit write up should include additional information about the processes and decisions used to develop the exhibit.
- 5. Subject matter must be in good taste and be appropriate for public display in a 4-H setting.

6. Photographs depicting unsafe practices or illegal activities will not be displayed.

Class No. 10345 – Photography Idea/Educational Display

An exhibit that demonstrates learning about photography that does not fit into any previous photography class. This class may include educational displays about printing, processing, editing, marketing, branding, merchandising, etc., as it relates to photography. Display board size may not exceed 48 inches by 48 inches.

Class No. 10540 - Digital Storytelling

An exhibit that demonstrates the application of technology to produce a creative film/movie/video. Exhibits may include a finished movie or video, creation of a detailed storyboard, editing techniques using digital video software, production techniques, or other display to share what was learned. Copyright permission must be obtained for any non-original material included as part of a film/movie/video. Finished film/movie/video must be uploaded to YouTube.

Class No. 10350 - Visual Arts - Original Art

An exhibit that shows learning through creation of original art. Original art is a one of a kind, non-replicable design of your creation. By using one medium or a combination, an individual creates an authentic work of art that is not recognizable as another's work. You must explain the application of the most relevant design element(s) and art principle(s) featured in this exhibit. Describe your inspirations, reasons, feelings, and/or motives for creating this work of art.

Class No. 10355 – Visual Arts – Design, Process, or Technique Exploration

This class emphasizes process and provides the opportunity to explore a medium, practice a skill, or study and apply elements and principles of art and design. An explanation of the application of design elements or art principles used when making the exhibit **must be included**. This exhibit may be an object, portfolio, display, poster, or organized sketchbook. If a non-original design source is used, its origin (where the idea was found, any pictures, sketches, etc.) must be credited, acknowledged or have copyright permission obtained. See visual arts special rule #5 and #6.

Class No. 10360 – Visual Arts – Other Visual Art Ideas/Topics

Exhibits might include the study and research about an individual artist, style, craft, business or marketing process, planning group tour, career options, etc

Visual Arts Special Rules:

- 1. Items entered must be ready for display in the home, gallery, or intended final display location: pictures framed, wall hangings and pictures ready to hang, etc. Make sure hangers are strong enough to support the item. Command Strips or other quick attach products are usually not adequate hangers. Items not ready for display will be dropped one ribbon placing.
- 2. Exhibits made from kits or preformed molds will not be accepted. Exception: Preformed molds (greenware, whiteware) may be used to provide the appropriate surface for a process technique or application of original design.
- 3. If the exhibit is a finished art object, the source or inspiration of the design, design sketches, or other process for creating the object and design must be included. For additional information see the Visual Arts and Design Elements & Art principles Exhibit Tip Sheets at https://www.extension.iastate.edu/4h/exhibit-tip-sheets.
- 4. If the exhibit is a finished art object information must be included explaining the application of design elements and art principles used in creation of the work.
- 5. Original works of art must be a creative expression of a design unique to the artist, or represent a significant modification to an existing design to make a new and original statement by the artist.
- 6. Exhibition of derivative works created by a 4-H'er is prohibited without the written permission of

the original copyright holder/owner. Use of copyrighted or trademarked designs, images, logos, or materials in 4-H visual arts exhibits is prohibited unless written permission has been obtained from the copyright or trademark holder/owner. For additional information, see 4-H Exhibit Copyright Information at https://www.extension.iastate.edu/4h/visual-art.

Family & Consumer Sciences

Class No. 10410 - Child Development

An exhibit that shows learning about children. An exhibit could include careers in child development, caring for children with special needs, childcare, growth and development, or safety and health. An exhibit that includes items intended for use with children, such as babysitting kits, books, learning games, or toys, must include information about what you have learned about children while creating and <u>using</u> the exhibit OR what the child/children learned from their use of the item(s) in the exhibit.

Class No. 10420 - Clothing and Fashion - Constructed/Sewn Garments & Accessories

A constructed garment or accessory (sewn, knitted, crocheted, or other process) that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics, and/or clothing care. Exhibits must be intended to be worn by humans.

Class No. 10422 - Clothing and Fashion - Purchased Garments & Accessories

Purchased garments or accessories that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics, and/or clothing care. Exhibits must be intended to be worn by humans.

Class No. 10424 - Clothing and Fashion - Other Ideas/Educational Exhibits

Any other educational exhibit that shows learning about clothing and fashion including but not limited to design illustrations, exploration of clothing styles, careers, clothing care, etc.

Only garments entered in the Fashion Revue category of the Clothing Event may also be entered as a static exhibit. Garments entered in the Clothing Selection or \$20 Challenge may NOT be entered as a static exhibit.

Class No. 10430 - Consumer Management

An exhibit that shows learning through savvy budgeting, comparison shopping, money management, or consumer rights and responsibilities.

Class No. 10440 - Food & Nutrition - Prepared Product

An exhibit of a prepared or preserved food product that shows skills or learning about cooking, baking, eating and choosing healthy foods, safety practices, or food preservation through the making of a prepared food product. See *Food & Nutrition Special Rules* below and HS 76 "Foods for Iowa 4-H Fairs – Quick Reference Guide" at https://store.extension.iastate.edu/product/6434 for additional information regarding prepared and preserved food products. Display boxes are not allowed for prepared products at the lowa State Fair.

Class No. 10442 - Food & Nutrition - Preserved Product

An exhibit of a preserved food product that shows skills or learning about food preservation through the making of a preserved food product. Processed honey may be exhibited in this class. See *Food & Nutrition Special Rules below and HS 76 "Foods for Iowa 4-H Fairs — Quick Reference Guide"* at https://store.extension.iastate.edu/product/6434 for additional information regarding prepared and preserved food products.

Class No. 10445 - Food & Nutrition - Educational Display

An educational exhibit (poster, report, display) that shows skills or learning about cooking, baking, eating and choosing healthy foods, meal planning/preparation & service, safety practices, or food preservation. See *Food & Nutrition Special Rules* below and HS 76 "Foods for lowa 4-H Fairs – Quick Reference Guide" for additional information regarding prepared and preserved food products. Exhibits showing learning about meal planning & service must include menu.

Food & Nutrition Special Rules:

- 1. Any exhibit considered to be a food safety risk or portray a food safety risk will not be accepted, judged or displayed.
- 2. All food products/exhibits should be appropriate for human consumption.
- 3. Food product exhibits must be prepared, baked or cooked using only food grade utensils and containers.
- 4. Products that require refrigeration will not be accepted, judged or displayed.
- 5. Meat jerky products are prohibited.
- 6. The recipe must be included for any prepared or preserved food exhibit; credit the source of the recipe.
- 7. Preserved foods must include the "Food Preservation Exhibit Label". Only food processed after August 1, 2023 is acceptable for the 2024 fair. Current USDA and/or lowa State University guidelines for home food preservation must be used. Processed honey must include the Honey Exhibit Label.
- 8. Preserved food exhibits **must** include **two** product samples. One will be opened for evaluation and sold at the 4-H bake sale with proceeds going to the 4-H Foundation; the second will not be opened, will be placed on display in the fair booth, and the exhibitor may take it home after the fair.
- 9. Prepared foods should be placed on a firm **disposable** plate or flat cardboard. Place food product exhibit in a re-closable plastic bag labeled with your name. A small amount of the product will be retained for display in the fair booth, the rest will be sold at the 4-H bake sale with proceeds going to the 4-H Foundation.
 - i. Recommended number of items to include with the exhibit;
 - 1. Cookies, cupcakes, bars, muffins, rolls, etc. four (4) to six (6) items
 - 2. Cakes loafs, pies, etc. one (1) whole product.
- 10. The use of alcoholic beverages in the preparation or production of 4-H food exhibits is NOT permitted.

Class No. 10450 - Health

An exhibit that shows learning through food choices, physical activity, safe activities, skills such as first aid and CPR, careers, and/or healthy lifestyle choices.

Class No. 10460 - Home Improvement

An exhibit that shows learning in planning, improving and caring for your home living space. Exhibits may include new or refinished/reclaimed/restored items. Exhibits showing learning about home design, furniture, home accessories, and fabrics must include information about how design elements and art principles were applied. *Fill out page on back of goal sheet on information for design elements and art principles* Home Improvement Special Rule:

- Items entered must be ready for display in the home: pictures framed, wall hangings and pictures ready
 to hang, etc. Make sure hangers are strong enough to support the item. Command strips or other quick
 attach products are usually not adequate hangers. Items not ready for display will be dropped on
 ribbon placing.
- 2. Exhibit write up/information must include source of inspiration and/or references indicating where the idea or information was obtained, giving credit to original author(s), designer(s), artist(s).

Class No. 10470 - Sewing and Needle Arts - Constructed Item

A constructed item (sewn, knitted, crocheted, or other process) that shows learning and skill in sewing, knitting, crocheting, or other needle arts. May include the construction of household items such as pillowcases, curtains, table runners, quilts, wall hangings, etc. Exhibits in this class are not intended to be worn by humans.

Class No. 10472 - Sewing and Needle Arts - Other Ideas/Educational Exhibits

Any other educational exhibit that shows learning about sewing and needle arts including construction techniques, use and care of fabrics and fibers, design illustrations, decorative processes, careers, etc.

Note: Exhibits in classes 10460, 10470 and 10472 should include information about application of design elements and art principles for the exhibit on the back of goal sheet

Class No. 10480 - Other Family and Consumer Science

An exhibit that demonstrates learning about a family and consumer science topic that does not fit any other previous Family & Consumer Science class listed.

Thrifty Meal Challenge

10490 - Thrifty Meal Challenge

Create a balanced, nutritious meal for family of four (4) that includes a serving from each of the five food groups with a budget of \$11.

Thrifty Meal Challenge Special Rules:

- 1. Each county may advance one (1) exhibit in this class to the lowa State Fair.
- 2. All entries will receive an evaluation and ribbon.
- 3. Exhibit may be from an individual or group effort.
- 4. The total expense on receipt(s) must not exceed \$11.00.
- 5. The meal must serve four (4) people, with a serving for each person from each of the five (5) food groups: Fruit, Vegetable, Protein, Grain, and Dairy.
 - a. Recommended portion sizes per person: ½ cup fruit, ½ cup vegetable, 3 ounces protein, 1-2 ounces grain, 1 cup equivalent dairy.
 - b. If there is a dairy allergy, you may substitute it with a calcium-rich item, but you will need to indicate the allergy and identify how the item substituted provides enough calcium.
- 6. The exhibit will be a poster (maximum size 20 inches by 30 inches) that includes:
 - a. A copy of the Thrifty Meal Challenge worksheet attached to the back of the poster.
 - b. The menu, outline of food items, and appropriate portion sizes for each food item.
 - c. Meal type (breakfast, lunch, dinner)
 - d. Copy of grocery receipts (up to 2)
 - e. Photos of the experience: grocery shopping, food preparation, and prepared meal.

Personal Development

Class No. 10510 - Citizenship and Civic Engagement

An exhibit that shows learning about or contributing to your community, your country, or your world.

Class No. 10520 - Communication

An exhibit that shows learning about written, oral, and visual communication skills. Includes learning from participation in Theatre Arts projects or programs such as puppets, stage design, etc. May include original

creative writing, poetry, fiction and non-fiction, etc. If finished exhibit includes audio or video, it must be uploaded to YouTube.

Class No. 10530 - 4-H Poster Communication Exhibit

Special poster exhibit to visually tell a story or idea about 4-H to the general public. Exhibitors must use one of the following themes:

- 4-H is... (open to 4-H'er's interpretation)
- O Join 4-H
- I <3 4-H (2023 National 4-H Week Theme)
- Explore the Jungle of Opportunities (variation of 2024 Iowa 4-H Youth Conference theme)
- 4-H Fever (variation of 2024 lowa State Fair theme)

Poster Communication Special Rules:

- 1. Only one (1) poster per 4-H member may be entered. Limit of two posters per county can advance to the lowa State Fair.
- 2. All posters must be designed on, or affixed to, standard poster board or foam core board—size minimum of 14 inches by 20 inches or maximum of 15 inches by 22 inches.
- 3. Posters may be vertical or horizontal. Posters may be any medium: watercolor, ink, crayon, acrylic, charcoal, oils, collage, etc.
- 4. Posters <u>cannot</u> be 3-dimensional. Materials used to make the poster may <u>not</u> extend more than 1/8 inch above the poster or foam core board.
- 5. Each poster <u>must</u> have the completed "Poster Exhibit Entry Form" attached to the back.
- 6. Posters cannot use copyrighted material or exact copies of other promotional designs, such as the Iowa 4-H Youth Conference theme logo.
- 7. 4-H members may include the 4-H clover in the poster.
- 8. Posters will receive premium money—\$5 blue, \$4 red, \$3 white.
- 9. Two posters made by 4-H'ers in grades 5-12 will be chosen to go on to the Iowa State Fair and will also receive special awards during the Fair Awards Program on Sunday of the fair at 3:30 PM.
- 10. 4-H'ers in grades 4-6 may receive outstanding junior honors for their 4-H poster.

Class No. 10540 - Digital Storytelling

An exhibit that demonstrates the application of technology to produce a creative film/movie/video. Exhibits may include a finished movie or video, creation of a detailed storyboard, editing techniques using digital video software, production techniques, or other display to share what was learned. Copyright permission must be obtained for any non-original material included as part of a film/movie/video. Finished film/movie/video must be uploaded to YouTube.

Class No. 10550 - Leadership

An exhibit that shows learning about leadership skills and influencing others in a positive way.

Class No. 10560 - Self-Determined

An exhibit that shows learning as part of your 4-H adventure and does not fit any other class.

Personal Development Special Rule:

1. Exhibits entered in the Personal Development classes should include reflection by the 4-H member stating how they personally grew or benefited from the exhibit. Why was this exhibit important to them as a person?

Science, Engineering & Technology

Class No. 10610 - Mechanics

An exhibit that shows skills or learning about general mechanics or engineering solutions or that involve a combination of skills.

Class No. 10612 - Automotive

Repaired or restored vehicle (Note: vehicles will be on display at the Iowa State Fair one day only, date is tentatively Thursday, August 8.)

Class No. 10613 - Automotive

Educational display showing learning about an automotive idea including automotive maintenance, auto operations, auto safety, or automotive systems.

Class No. 10614 - Electric

Constructed or repaired article or educational display that shows skills or learning about electric wiring, appliances, lighting, electrical energy sources, safety, etc.

Class No. 10615 - Small Engine

Repaired or restored operating engine or educational display or other type exhibit that shows skills or learning about small engines. This class includes repaired or restored lawn tractors, small motorcycles, go-karts, etc.

Class No. 10616 - Tractor

Repaired or restored tractor

Class No. 10617 – Tractor: Educational Display

An exhibit that shows learning related to tractors, tractor mechanics, tractor operation, or tractor safety.

Class No. 10618 - Welding

Constructed item or educational display that shows skills or learning about welding.

Class No. 10620 - Woodworking

An exhibit that shows learning about wood, woodworking techniques, and safe uses of woodworking tools and machines. Exhibits may include newly constructed or refinished/reclaimed/restored wood items.

Class No. 10632 - Aerospace

Educational display or other exhibit (including flyable models) showing learning about an aerospace idea or topic.

Class No. 10634 - Robotics

Educational display or other exhibit (including working robots) that shows learning about robotics and robotic systems.

Class No. 10630 - Science, Engineering, & Technology

An exhibit that shows learning about or helps explain how science and technology help us interact with the world. Topics include aerospace, biological and chemical sciences, computers & networking, earth & climate, geospatial mapping (GPS/GIS), robotics, or any other application of Science, Engineering, or Technology.

10. Exhibitors entered in the 4-H Science, Engineering, and Technology classes are not eligible to exhibit in similar FFA Ag Mechanics classes and vice versa.

- 3. Entry should be placed on a firm paper plate or flat cardboard, which is labeled with member's name & club in an inconspicuous place. Place plate & food in a large zip lock bag.
- 4. Challenge product must have an exhibit information form attached. A recipe card does not need to be attached, because everyone has used the same recipe.
- 5. The purpose of this contest is to use only the recipe that follows and make, bake and present your best plate of that product.
- 6. Each entry will be presented with a special challenge participation ribbon, with the top 3 being named in each division. Division winners will receive a 1st, 2nd or 3rd place ribbon with prize money of \$5.00, \$4.00, and \$3.00 given respectively.

7. Photos for 1st, 2nd, and 3rd place challenge recipe contest winners will be taken for the newspaper on Sunday at 2:30 PM.

2024 4-H Challenge Recipe

Bagels

Ingredients for Bagels:

- 3 ½ cups of bread flour
- 2 teaspoons instant yeast
- 1 teaspoon salt
- 1 ½ tablespoons sugar
- 1 ¼ cup room temperature water
- 1 tablespoon vegetable oil

Ingredients for Egg Wash:

- 1 egg
- 1 tablespoon water

Directions:

- 1. To begin the dough, mix all the dry ingredients together. Then add the water and oil. Start kneading the dough. The dough is ready when it is smooth with no dry clumps and does not stick to your hands anymore. Make sure not to over knead the dough.
- 2. Let the dough rest and rise in a covered bowl for 1 hour or more until it rises at least double in size.
- 3. Punch the dough and knead for a couple of minutes to release air bubbles after the dough rises. Divide the dough into 5 equal pieces and pre-shape into round balls.
- 4. Flatten the top of the dough balls, use a small cookie cutter or your fingers to make a 1-inch round circle in the middle of each dough ball. Let rise again for 10 minutes.
- 5. At this point you can go ahead and preheat the oven to 425 degrees Fahrenheit.
- 6. Fill a pot with water, put on the stove, and bring to a boil.
- 7. Drop each bagel in the hot boiling water (no more than 2 at a time), boil for 1 minute per side. Drain the bagels after boiling, place on a non-stick baking tray. This is to give the bagels a crust while keeping the insides soft.
- 8. Whisk the egg and water together to make the egg wash. Brush the egg wash on the top of the bagels.
- 9. Bake for 20 minutes or until the bagels are golden brown. Remove from the oven and allow bagels to cool.

BUCKETS OF FLOWERS

Class No. 10731 - Bucket of Flowers

- 1. Members may enter one entry.
- 2. Member must label the plants in the bucket, using some type of label using the common plant name.
- 3. Member must use a 3 to 5 gallon plastic bucket of their choice to plant flowers and/or plants in.
 - The use any other type of container for your plants to be in will not be allowed to be judged.
- 4. The bucket must be 1/2 full of Styrofoam (not dissolvable) packing peanuts, milk jugs, or something else to reduce the total weight of the bucket.
- 5. Make sure to de-head (remove) old or dead blossoms or leaves, trim brown spots, and make sure there is no bug infestations.
- 6. Buckets will be conference judged in Skateland along with other exhibits.
- 7. Buckets will be displayed around the fairgrounds during the fair for beautification.
- 8. Members will take buckets home after the fair.
- 9. Each bucket of flowers will receive a blue, red, or white ribbon. They will also be given a sticker to display on their exhibit information form while displayed outside around the fairgrounds.
- 10. An overall champion bucket of flowers will be chosen.

4-H PIE CONTEST

Class No. 10721 - Junior 4-H Pie Contest (Grades 4-6)

Class No. 10722 - Intermediate 4-H Pie Contest (Grades 7-8)

Class No. 10723 - Senior 4-H Pie Contest (Grades 9-12)

- 1. Members may enter only one pie in the 4-H Pie contest.
- 2. The recipe for the pie & the source of recipe must be included.
- 3. Pies will be entered on Tuesday with all other static exhibits and conference judged.
- 4. Pies must be baked "from scratch" and in a disposable container by a 4-H member in an Emmet County 4-H Club.
 - 1) Junior members only may use prepared canned pie filling.
- 5. Entry must be two-crust fruit pie. A lattice crust is acceptable. A crumb crust is not acceptable. No cream or "custard" pies may be entered—this includes pumpkin and pecan pies.
- 6. Each pie will be given a blue, red or white ribbon and be paid premium accordingly.
 - 1) Blue ribbon pies will be held back until the end of the judging day and a 1st, 2nd, and 3rd place in each age division will be chosen.
- 7. Fifty percent of the money from the sale of the pie will go to the 4-H'er and fifty percent will go to the Emmet County 4-H Foundation.
 - 1) The amount pies are sold for is determined by their ribbon ratings and placings.

Pies entered in the Pie Contest can also be considered for the Iowa State Fair if the judges choose. It is possible for a pie to receive a 1st, 2nd, or 3rd place ribbon for the Pie Contest, as well as be selected as a State Fair or State Fair Alternate exhibit (for 5th-12th graders).

CRAFT KIT CLASS

Class No. 10741 - Crafts & Craft Kits

- 1. Exhibits that were made by 4-H'er using a craft kit or is a craft, not an art.
- 2. Limit of 5 entries in this class all must have a different goal.

CLOTHING EVENT GENERAL RULES

- 1. All Clothing Event entries should be made online at www.fairentry.com and are due by July 8th.
- 2. One entry in each Clothing Event category is allowed per 4-H member per year.
- 3. Clothing Event judging will take place on Thursday July 11th. A schedule for interviews will be emailed/mailed to participants after July 8th. Please wear your outfit to your interview. Also, please bring along a photo of you in your outfit to leave with the judge.
- 4. The Fashion Show will take place on **Tuesday of the fair at 7:30 PM** in Skateland. All entrants will wear and model their outfits. Awards and recognition will be announced for each category.
- 5. Judges critique sheets will be handed out to participants following the Fashion Show.
- 6. Each Clothing Event entry will receive a blue, red, or white ribbon.
- 7. Court of Honor, Clay County Fair Selections, State Awardrobe Event selections and alternate winners will need to take a photo for the newspaper following the Fashion Show.
- 8. Senior 4-H members may be chosen to participate in only one category per year for the Iowa State 4-H Awardrobe Clothing Event. Those selected will receive an award at the Fair Awards Program on Sunday of the fair at 3:30 PM.

4-H FASHION REVUE

Class No. 12101 - Junior 4-H Fashion Revue (Grades 4-6)

Class No. 12102 - Intermediate 4-H Fashion Revue (Grades 7-8)

Class No. 12103 - Senior 4-H Fashion Revue (Grades 9-12)

- 1. The 4-H'er will exhibit and model an outfit he/she has constructed, hand-knitted, machine-knitted or crocheted during the current 4-H year in this category.
- 2. A garment or outfit consisting of one to three pieces such as party clothes, tailored suits, vest, slacks, shirt, skirt, active sportswear and/or coats are acceptable as Fashion Revue entries.
- 3. Blouses, shirts, and sweaters are usually considered as garments. If they are used to complete an outfit, they may be constructed or selected.
- 4. All other accessories and undergarments may be constructed or selected.
- 5. Emmet County will be eligible no more than two senior age participants in each category (male, female, minority) to enter the Iowa State 4-H Awardrobe Clothing Event.
- 6. State Fair and State Fair Alternate selections will be displayed in the State Fair booth at the county fair.
- 7. Up to 2 Juniors and up to 2 intermediates or seniors may be selected to participate in the Clay County Fair Clothing Event (TBD).

4-H CLOTHING SELECTION

Class No. 12201 - Junior 4-H Clothing Selection (Grades 4-6)

Class No. 12202 - Intermediate 4-H Clothing Selection (Grades 7-8)

Class No. 12203 - Senior 4-H Clothing Selection (Grades 9-12)

- 1. Clothing Selection is designed to help youth develop skills in selecting and/or purchasing an outfit that represents the 4-H member's goal or intended use for the selected outfit.
- 2. Outfits may be purchased from any source, including consignment shops, clothing stores, used clothing stores, etc. Clothing items which are home-sewn are not eligible unless the completed garment was

- purchased from a used clothing source. Clothing items, which are custom sewn specifically for the participant, are not eligible.
- 3. The 4-H member chooses the shopping alternatives, evaluates fit, quality, construction features, price and cost comparison.
- 4. Emmet County will be eligible to send up to 3 senior age participants (one female, one male, and one minority) to enter the Iowa State Fair 4-H Awardrobe Clothing Event. 4-H member may participate as many times as they are selected at the county level in the State 4-H Awardrobe Clothing Event.
- 5. State Fair and State Fair Alternate selections will be displayed in the State Fair booth at the county fair.
- 6. Up to 2 Juniors and up to 2 intermediates or seniors may be selected to participate in the Clay County Fair Clothing Event (TBD).

THE \$20 CHALLENGE

Class No. 12301 - Junior 4-H \$20 Challenge (Grades 4-6)

Class No. 12302 - Intermediate 4-H \$20 Challenge (Grades 7-8)

Class No. 12303 - Senior 4-H \$20 Challenge (Grades 9-12)

- 1. The class is designed to expand the 4-H member's shopping experience to include different shopping venues emphasizing recycling, reducing, and reusing. Outfits must be purchased at a garage sale, consignment store, thrift store, secondhand store, or similar place.
- 2. Online venues are allowed and must be second-hand in nature. Shipping and handling are not included in the total calculations.
- 3. Traditional shopping venues may not be used, regardless of a low regular or sale price. Hand-me-downs or gifts of clothing do not belong in this class, but rather belong in the Clothing Selection class, IF the 4-H'er actually selected the items(s).
- 4. Twenty dollars is the purchase price limit including tax. However, some secondhand stores and venues do not typically charge sales tax.
- 5. Receipt(s) for every item included as a part of the calculated total must be submitted with the entry. A garage sale receipt can be a piece of paper with the name of location such as "Jane Doe garage sale", date, amount paid, and a signature of person selling at the garage sale. If the outfit was free at a garage sale, "free" can be listed on the report form and on the receipt. Failure to provide receipts will be reflected in the evaluation.
- 6. Alterations are permitted to achieve a desired look or fit.
- 7. There are no additional considerations for an outfit that totals less than \$20.
- 8. The outfit pieces should be purchased to meet the 4-H member's goal or intended use for the purchased outfit, and the 4-H member should have had an experience in choosing shopping alternatives, evaluating fit, quality and construction features, price, and cost comparison.
- 9. All participants to qualify for participation in this event should:
 - 1) Outfits MUST be purchased from a garage sale, consignment store, or resale shop (i.e. Goodwill, Salvation Army, or other stores of this type).
 - 2) Cost of outfit must be \$20 or less, not including shoes, accessories, or undergarments.
- 10. Emmet County will be eligible to send up to 3 senior age participants (1 female, 1 male, 1 minority) to enter the Iowa State Fair 4-H Awardrobe Clothing Event. 4-H'ers may participate as many times as they are selected at the county level in the State 4-H Awardrobe Clothing Event.
- 11. State Fair Selections and Alternates will be displayed in the State Fair booth at the county fair.
- 12. Up to 2 Juniors and up to 2 intermediates or seniors may be selected to participate in the Clay County Fair Clothing Event (TBD).

INNOVATIVE DESIGN

Class No. 12401 - Junior 4-H Innovative Design (Grades 4-6)

Class No. 12402 - Intermediate 4-H Innovative Design (Grades 7-8)

Class No. 12403 - Senior 4-H Innovative Design (Grades 9-12)

- 1. The purpose of this class is to encourage creativity and out-of-the-box thinking when creating an outfit.
- 2. These designs can be theatrical costumes, cosplay, wearable technology, sustainable/upcycled fashion, accessible fashion, and/or outfits that use unconventional materials.
- 3. The outfit must be showcased as a worn garment modeled by the exhibitor or by the individual that it was designed for.
- 4. Exhibitors may make their garment entirely, or permanently alter the silhouette of pre-existing materials through some method of permanent alteration or addition.
- 5. Consideration is given to originality and innovation.

COMMUNICATION EVENT GENERAL RULES

- Communications entries are made on fair entry by June 17. The Communications event will be June 23.
- 2. The Communication Event program provides opportunities for 4-H youth to develop their personal communication skills by sharing talents, knowledge, or information with others. The events provide a series of development experiences for different age levels.
- 3. Educational Presentations, Working Exhibits, Share-The-Fun acts, and Extemporaneous Speeches are judged in the spring at the Clover Knowledge Escapade.
- 4. Educational Presentations and Working Exhibits may be given by one or more 4-H'ers. Share-The-Fun acts may be presented by individuals, teams, or groups.
- 5. Topics selected by the 4-H'er(s) should be an outgrowth of his/her 4-H experience(s). Topics should be appropriate for presentation to a general audience.
- 6. Participants in the 4-H Communication Programs are expected to wear appropriate clothing representative of the 4-H Youth Program and/or the topic of the presentation.
- 7. 4-H'ers must use sanitary and safe procedures and methods at all times. Educational Presentations and Working Exhibits involving food must follow established food safety guidelines.
- 8. All participants are expected to comply with all copyright/trademark regulations. Copyrighted material may not be distributed without permission.
- 9. Each Communication Entry will receive a blue, red, or white ribbon with premiums. For group entries, each member of the group will receive a ribbon and premium money for that entry.
- 10. Those 4-H'ers who have communication events advancing to either the Iowa State Fair or Clay County Fair, will also present their communication entries on Thursday of the Emmet County Fair at the 6:30 PM Communications Showcase (prior to the 4-H Clothing Event).
- 11. 4-H members who have completed 5th grade through 12th grade (or equivalent) in 2024 are eligible to participate at the Iowa State Fair. Exception: Share-The-Fun and Extemporaneous Speaking See class rules for age guidelines.
- 12. Stickers may not be allowed in any Communication Event for any reason.
- 13. If live animals will be used as part of a Communications Event, the exhibitor must comply with the 2024 Health Requirements for the Exhibition of Livestock, Poultry and Birds at State Fair, District Shows and Exhibitions. This can be found at https://iowaagriculture.gov/animal-industry-bureau/animal-admission-health-requirements. Animals that do not comply will not be allowed for the communications event.
- 14. Emmet County can send a maximum of 1 educational presentation, 1 working exhibit, and 1 share the fun entry on to the Clay County Fair. Participants could be in 4th-12th grade.

EDUCATIONAL PRESENTATIONS

Class No. 11101 - Junior Educational Presentation (Grades 4-6)

Class No. 11102 - Intermediate/Senior Educational Presentation (Grades 7-12)

PURPOSE: Provide an opportunity for 4-H members to demonstrate communication skills by presenting knowledge, information, or a process to an audience.

- 1. Youth may participate in one Educational Presentation per year.
- 2. The topic of the presentation should determine its length, but intermediate/senior level must not exceed 20 minutes and Junior presentations must not exceed 15 minutes. Presenters will be verbally told to 'STOP' when they exceed the time limit.
 - 1) If selected for the Clay County Fair, all presentations must not exceed 15 minutes. Exhibitors will verbally be told to "STOP" when they exceed the time limit.
- 3. Presentation content must be the original work of the presenter(s).
- 4. Up to 6 Educational Presentations may be selected to advance on to present at the Iowa State Fair.
- 5. One Educational Presentation may be selected to advance on to present at the Clay County Fair.

WORKING EXHIBITS

Class No. 11201 - Junior Working Exhibit (Grades 4-6)

Class No. 11202 - Intermediate/Senior Working Exhibit (Grades 7-12)

PURPOSE: Provide an opportunity for 4-H members to communicate, interact with, and teach an audience in an informal and experiential way.

- 1. Youth may participate in one Working Exhibit per year.
- 2. Many stages of the exhibit or product should be ready so that any step can be discussed.
- 3. The best subjects involve action of the members or involve the audience in some doing, feeling, tasting, smelling or judging.
- 4. All methods used should be safe for involvement by audience of all ages.
- 5. Up to 4 Working Exhibits may be selected to advance on to present at the Iowa State Fair.
- 6. One Working Exhibit may be selected to advance on to present at the Clay County Fair.

SHARE-THE-FUN

Class No. 11300 - Share-The-Fun (Grades 4-12)

PURPOSE: Provide an opportunity for 4-H members to share their skills and talents before an audience purely for the sake of enjoyment.

- 1. Skits, songs, stunts, short one-act plays, dance, and other entertainment will be acceptable. All performances must be appropriate for presentation to a general audience.
- 2. The entry must not exceed six minutes in length.
- 3. Any 4-H'er that has completed 5th-12th grade (or that equivalent) in 2024 is eligible to be selected to participate at the lowa State Fair. Note: if a performing group is involved, at least 80% of the performing group must have completed 5th through 12th grade this school year to be eligible for the lowa State Fair.
- 4. Up to 3 Share-the-Fun entries may be chosen to advance on to present at the Iowa State Fair.
- 5. One Share-the-Fun act may be selected to advance on to present at the Clay County Fair.

EXTEMPORANEOUS SPEAKING

Class No. 11400 - Extemporaneous Speaking (Grades 9-12)

PURPOSE: Encourage the development of communication skills by providing an opportunity to think, organize thoughts, prepare a speech, and respond to questions when given a limited amount of preparation time.

- 1. Participants must have completed grades 9th-12th (or that equivalent) in 2024 to enter this class.
- 2. Emmet County is allowed to send up to two (2) entries to the State Fair in this area.
- 3. Program format:
 - 1) Thirty minutes before the speech, each participant will draw 3 of the available topics, selecting one to speak on. The selected topic will not be available to the other participants. The other 2

- not chosen will be returned to the available topics for other participants. The general nature of the topics will relate to 4-H.
- 2) A preparation room is to be used by each participant. A participant may not leave the preparation room until it is time to speak, nor may a participant receive help from a parent, leader, other adult, or any other youth. A program official will assist participants with the time requirements.
- 3) All reference material will be screened by a program official on the following basis:
 - i. Contestants may bring their own books, magazines, or newspaper clippings for reference during the thirty minutes of preparation.
 - ii. Reference material must be printed material such as books or magazines (cannot be notes, outlines, or speeches prepared by the contestant or by another person for use in this program).
 - iii. Some relevant reference material will be available in the preparation room. This material will consist of historical material related to the 4-H program.
- 4) Each speech shall be the result of the 4-H members own efforts using approved reference material that a participant may bring to the preparation room. No other assistance may be provided. Plain 3"x5" note cards will be provided for each contestant in the preparation room. If notes are used, the 3"x5" note cards provided must be used in delivering the speech.
- 5) Only notes made during the preparation period may be used.
- 6) Each speech shall be not less than 4 but no more than 6 minutes with an additional 5 minutes allowed for related questions, which shall be asked by the judge. The contestant will be shown timecards in an ascending order (1 5) by the timekeeper. "Stop" will be said at 6 minutes.
- 7) Each contestant will be introduced by a timekeeper by name and club he/she belongs to. The contestant will be expected to introduce his/her speech by title only.
- 8) Participants are not permitted to use any props, gadgets, posters, or audio-visuals of any sort. A podium will not be available.
- 4. Speeches will be evaluated using the following criteria: content related to topic, knowledge of the subject, organization of material, power of expression, voice, stage presence, general effect, and response to questions.

It may be helpful to use these terms and information when filling out "Exhibit Information Forms" for Clothing & Fashion, Home Improvement, and Visual Arts classes.

Elements of Design & Principles of Art

ELEMENTS of DESIGN

LINE: Line is any mark that is greater in length than it is in width. Line can be vertical, horizontal, diagonal, straight, curved, dashed, zig-zag, thick, or thin. Line can show direction, draw your attention, outline an object, divide a space, or communicate a feeling.

SHAPE: Shape is a closed line. Shapes can be geometric, like squares and circles; or organic, any free formed shapes or natural shapes. Shapes are flat and express length & width.

FORM: Form is any three-dimensional shape that expresses length, width, and depth. Spheres, cubes, cylinders, and pyramids are all forms.

SPACE: Space is the area between and around objects or the area that a form occupies. The space around objects is often called negative space; and the space that an object occupies is often called positive space. Space can also refer to the feeling of depth. Real space is three-dimensional, but space can also be represented on a

two-dimensional surface creating a feeling or illusion of depth. Space also relates to objects appearing close or far away.

TEXTURES: Texture is the surface quality that is experienced through touch or the illusion of touch. Textures can be rough or smooth, soft or hard.

COLOR: Color is the quality of the light reflected off an object. Color is described using hue, value, and intensity. Hue is the name of the color (red, green, blue, etc.), value is how light or dark the color is (light blue, navy blue), and intensity is how bright or dull the color is (4-H green, neon green)

PRINCIPLES of ART

BALANCE: Balance is achieved by creating a feeling of equality of visual weights throughout a composition. Balance can be symmetrical (two sides the same), asymmetrical (two sides are different in some way but feels balanced), or radial (objects radiate from a certain point).

MOVEMENT: Movement is achieved by defining visual pathways for the eye to travel through a composition, which sometimes can be achieved through repetition of color, texture, shape, form, or line.

RHYTHM: Rhythm is achieved by punctuating the visual pathways of a composition in such a manner that it allows the viewer to gauge the progression through a composition (dramatic-fast or static-slower).

ECONOMY: Economy is achieved by distilling a composition to its bare essentials in order to create visual clarity without losing the essence of the object (very minimal details, no ornamentation, etc.).

EMPHASIS: Dominance is achieved when the elements in a composition are organized in such a manner that some element(s) is/are perceived as being more important than others (through color, size, space, etc.).

SCALE: Scale is the comparative relationship of size among the different elements of a composition.

PROPORTION: Proportion is the comparative relationship of size within each element of a composition (comparing height, weight, size, etc.).

UNITY: Unity is achieved when all elements of a composition seem as a whole to belong together (through color, texture, line, shape, form, etc.)
