Prior to fair:

- Complete the 4-H Exhibit Goal sheet available on google doc online:
 (https://www.extension.iastate.edu/hancock/4h/hancockcounty_districtfair) and gather all supporting
 materials such as photos, plans, receipts. For photos be sure to use the Photography label. Refer to the
 fairbook for additional guidelines on exhibits. Consider putting all your documents in a folder or plastic
 sleeves to contain them.
- Attach your enclosed exhibit tags to your projects so we know who to recognize for your hard work. You can
 do this by string or tape. It is best to attach directly to the exhibit in case your exhibit gets separated from
 your write up and supporting paperwork.
- Wearing a 4-H t-shirt for judging is encouraged. T-shirts are \$8 and can be purchased at the Extension Office or at the fair office during fair.
- Make yourself an exhibit kit, including a pen, tape, string, stapler, and other things you may need to prepare or set up your exhibit at the fair.

Steps at fair:

- Come during your assigned club/team time.
- Check in at the 4-H Exhibits Building. You will receive your exhibitor judging list that the judges will record your placings on.
- Tables will be set up in both the 4-H exhibit building and the Red Brick building for exhibit staging so you can set down your exhibits and prepare them for judging.
- Sit with the judge and talk about your exhibit and what you learned.
- Once you are done talking with all judges, take your exhibit list sheet to the ribbon table to receive your exhibit ribbons.
- Attach your ribbon on your exhibit and place it on the display tables along with your name card in the 4-H
 exhibit building. (If the judge is holding your exhibit back to be considered for State Fair, those exhibits will
 stay behind the individual judges.)
- Take your exhibit list sheet to the fair office to get paid for your premiums.

Exhibit pick up:

- All Exhibits will be released at 4:30 pm on Sunday, July 30th.
- If you have exhibits that were selected for State Fair, please be sure to read the note attached to your exhibit and connect with 4-H staff about additional instructions.

Static Exhibit Online Auction

Each 4th-12th grade 4-H member has the option to put one exhibit on our new 4-H Static Exhibit online auction. Participation is optional. The auction item you choose will be sold to the highest bidder and not be returned to the 4-H member. You will be asked at check in to indicate which item, if any, you are designating to be sold on the auction.

If an auction item gets selected to advance to State Fair you have 2 choices:

- 1. Send only a binder with detailed photos and all your paperwork, goal sheet, and supporting material to the State Fair and auction the exhibit at county fair.
- 2. Select an alternate exhibit to be auctioned and send your State Fair selected exhibit to State Fair.

Food: If you choose to auction a baked good, you must provide a fresh item to be picked up on Sunday, July 30th at 4:00 pm for the auction buyer.

There is no pre-entry for horticulture judging. Flowers and vegetables will be judged on Tuesday, July 25 from 12:00 pm – 3:30 pm.
