### **Rules & Regulations for Contest**

#### **Eligibility Requirements:**

- Applicant must be or have been active in 4-H and/or FFA work in Johnson County.
- Applicant or their family must be a current member of the Johnson County Cattlemen's Association if applicant doesn't hold a current membership a (3) year membership needs to be purchased before the contest.
- Applicant should be a junior or senior in high school or in the first year of college.
- Applicant must meet with the selection committee for personal interview on the date and time to be determined by the Johnson County Cattlemen's Association judges.
- At the time of the interview Applicant will be required to give a presentation, to a panel of three judges, on the subject of cattle or the cattle industry.
- Applicants are expected to attend events representing the Johnson County Cattlemen during their reign: Jo. Co. Fair (2) days, ISF Beef Quarters, 4<sup>th</sup> of July Parades.

#### **Helpful Hints:**

- Choose a topic that you will be comfortable presenting to the judges
- Practice your presentation in front of others
- Make good eye contact with the judges
- **DO NOT:**
  - Use poor visual aids
  - Give too much information
  - Read a text
  - Give too long a presentation (limit to 5 – 8 minutes)
  - Have no sense of purpose
