#### **Monday, July 15**

**Non-Livestock 4-H Exhibit Judging** will be held on Monday, July 15 in the Exhibit Hall and 4-H Building from 8:30-2:30 PM. This judging is also referred to as Static Exhibit Judging. Please see your 4-H & FFA Fair Rule Booklet on pages 40-51 for full class descriptions and more details about preparing exhibits for the fair. Several livestock weigh-ins and check-ins will also take place on Monday, July 15, so please check out the schedule on page 13 of this newsletter. If you are involved in several fair events, please check the schedule and create your own family schedule for fair week, #organization! Additionally, the Llama and Dog Shows will take place on Monday.

#### **Tuesday, July 16**

**4-H Horticulture Judging** will take place in the 4-H Building between 2:00-4:00 PM. Full details can be found on pages 52-53 of the 4-H & FFA Fair Rule Booklet.

## Clover Kids Corner – County Fair Edition

Clover Kids and WonderLeague Members are eligible to participate in the Southern Iowa Fair. They may bring up to 5 exhibits in the Exhibit Hall, Pets in the Pet Show, and a Dog in the Dog Show (must complete the required 4-H & Clover Kids Dog Classes to be eligible). Dogs must have been pre-registered in 4hOnline Animal Identification by May 15.

Exhibit judging will take place on **Monday, July 15 at 2:00 PM** in the Exhibit Hall at the Clover Kids booth. Clover Kids may bring exhibits similar to 4-H'ers, but may not use kits. For example, a Clover Kids member may bring a picture frame made out of craft sticks, a matted photo they have taken this year, chocolate chip cookies, or a birdhouse. They may not bring items from a purchased craft kit, like those at Walmart and craft stores. All Exhibit Hall exhibits will stay on display in the Exhibit Hall until 8:00 PM on Saturday, July 20. Exhibits **must be** picked up by 3:00 PM on Sunday, July 21 (building will be open from 1:00-3:00 PM on Sunday).

Clover Kids bringing Pets for the Pet Show will check in by 3:00 PM at the Free Stage on **Thursday, July 18**. Pet Show details can be found on page 30 of the 4-H & FFA Fair Rule Booklet.

If you plan to exhibit at the fair and would like to receive a family ticket to the Key Coop BBQ on Monday and/or individual member tickets for the Farm Bureau & MCARD BBQ on Thursday, please contact Ashtin for additional details and to request BBQ tickets.

## 4-H Office Hours

The 4-H Office will be open from 8:00 AM-5:00 PM on Monday-Friday of fair week. Even though we may be in the office in the evening, we will be working on news releases and show orders with our volunteers and the office will be closed.

## Livestock Drug Affidavits

The Livestock Affidavits are the Iowa 4-H Animal Care and Management Disclosure Statements (records of your animal's medication/treatments). **These forms are due by no later than 10:00 AM on Friday, July 19 in the FAIR BOARD OFFICE at the fairgrounds.** These forms are required for 4-H & FFA animals in the following species:

**Poultry, Rabbit, Market Lambs, Beef, Swine, Meat Goats, and Horses ONLY.** Horse Affidavits can be turned in at the Vet Check prior to fair or during fair check-in. Animals will not be permitted to sell in the Fair Auction without this form! Forms can be obtained at the Extension office and online at <https://www.extension.iastate.edu/mahaska/page/livestock-exhibiting-information>.

## Livestock & Special Events Entry Form

At the fair, your Livestock & Special Event Entry Form will be located in your Exhibit Hall club booth (or your leader will have it). You **must** fill it out if you will show any livestock, dog, pets, clothing event, communications, or horticulture. This form is for 4-H & FFA. **NEW THIS YEAR—**You must turn your completed form in to the 4-H OFFICE by 4:30 PM on Friday, July 19—**NO EXCEPTIONS.** Changes will not be made to these forms after 4:30 PM on Friday, July 19. 4-H & FFA Members are required to complete and submit forms. This is the form we will use to create premium cash outs for each member.

## Fair Cash Out July 31—READ THIS CHANGE!

We will hold a Fair Premium Cash Out Day on **Wednesday, July 31** between **8:00 AM-8:00 PM**. Members do not have to be present to receive their cash out, but someone must come in and sign for their fair premiums. Since club accounting has changed, this is our solution to club premium checks. Premiums will reflect what was recorded and submitted on the Livestock & Special Events Entry Form and Static Exhibit Entry Form (turned in to ribbon table during Monday judging). Premiums not picked up on July 31 will automatically go back into our 4-H & FFA Youth Shows Fair Fund, no exceptions. If you have any questions, please contact the Extension office at 673-5841.

## Bucket'o'Junk Judging

All entries will be judged in the 4-H Building (small building just south of the Sheriff's Posse trailer) on **Monday, July 15** between **8:30 AM-2:00 PM**. Please wear a 4-H shirt. You must sign-in when you get to the 4-H Building and wait for your name to be called. You will visit with a Science, Mechanics, and Engineering judge. Please bring an exhibit goal sheet with you to the conference judging. The exhibit goal sheet must include answers to the following questions: What was your exhibit goal(s)?, How did you go about working toward your goal(s)?, and What were the most important things you learned as you work toward your goal(s). Be sure to emphasize the welding skills you gained in your answers; photos are beneficial. Adult mentors, if utilized, are welcome to attend conference judging with you. Once judging is complete, please collect your ribbon from the front check-in table and bring your exhibit to the Exhibit Hall for display. We will have a 4-H Bucket'o'Junk display in the Exhibit Hall this year that will include "People's Choice" voting. Your exhibit is yours to keep at the end of the fair. We will not have a Bucket'o'Junk Auction this year. If you have any questions, please contact Seth Van Zante at 641-660-1578 or Nick Hughes at 641-799-0015.

## 4th Grade Exhibit Judging

4th graders will report to one judge to have all of their non-livestock (static) exhibits judged, with the exception of Photography, Ag & Natural Resources, and Science, Engineering, Technology, and Mechanics, which will be judged in the 4-H Building (where the 4-H Office is located—go through overhead garage door). For all other exhibits, we will have one judge available for educating youth, evaluating exhibits, and selecting 4th Grade Special Exhibits to go into the Outstanding 4th Grade Exhibits Booth in the Exhibit Hall. Judging will take place on **Monday, July 15** at the time specified for your club on pages 44-45 of the 4-H & FFA Fair Rule Booklet. 4th graders will not go to any other judges, except for the exhibit areas listed above. Outstanding 4th Grade exhibits are those that would be considered for state fair, if the 4-H'er were eligible. Currently, state fair eligibility does not start until the youth have completed 5th grade.

## Hall Monitoring at the Fair

Each 4-H club and Clover Kids group has been assigned a time to monitor the Exhibit Hall or 4-H Building on the fairgrounds. The schedule can be found on pages 58-59 of the 4-H & FFA Fair Rule Booklet. Clubs will need to sign-in and wear name badges during monitoring. The sign-in sheets and name badges (sticker labels) can be found inside a black clipboard on the wall next to the interior door to the 4-H office, inside of the 4-H Building (near the black display case). Please enter the 4-H Building through the main overhead door. Clubs must cover their assigned time and any clubs that do not sign-in and cover their assigned times will forfeit any club awards or Herdsmanship premiums. Clubs can feel free to provide an activity in the Exhibit Hall or 4-H Building during their monitoring time. Some activity ideas include doing 4-H trivia with small prizes, putting on tattoos, coloring pages, simple make'n'take crafts, games, puzzles, or handing out 4-H Exhibit Info sheets. New this year is the People's Choice voting for Bucket'o'Junk. Instructions will be in the sign-in sheet clipboard. Additional details about Hall Monitoring can be found on page 58 of our rule booklet.

## Herdsmanship

Herdsmanship (Barn Prize) will be judged once per day in the evening. Also, each barn will be judged *after* all livestock has been removed at the fair's end. Those leaving the barns dirty will be notified to come back and clean their area. If the barn is not cleaned, the member *and* club will forfeit any prizes for Herdsmanship that they would have earned prior to check-out. Full details and judging schedule will be posted in the 4-H Building. Also, see pages 38-39 of the rule booklet for details.

## Livestock Judging Contest

The Livestock Judging Contest will be held on **Friday, July 19** in the Sale Ring. Registration will be from 1:30-2:00 PM and the contest will begin at 2:00 PM. This contest is open to anyone. There will be divisions for 4-H, FFA, & Open. Teams will be made up of 3-4 individuals from the same club or chapter. Youth teams will be divided into 4-H Junior, 4-H Intermediate, 4-H Senior, and FFA. Full details can be found on page 25 of the 4-H & FFA Fair Rule Booklet, please note the updated location. Winners will be announced just before the auction on Saturday, July 20. In case of extreme heat, this event will be cancelled. Please contact a FFA Advisor or listen for announcement at the fair.

## Bedding & Mulch for Barns

4-H & FFA members are responsible for purchasing and placing their own bedding and mulch. Some clubs help with purchasing and placement of the mulch in the cattle barn, please visit with your club leader for more details. Bedding will be available to purchase at the fair or you may bring your own. Bedding disposal is located south of the lower cattle barn near the beef tie out area. Exhibitors are responsible for keeping their stalls/cages clean.

## Auction Verification at Fair

Those planning to sell animals at the Southern Iowa Fair must read pages 10-11 of the 4-H & FFA Fair Rule Booklet. All exhibitors are **required** to verify auction animals in the FAIR BOARD OFFICE by 10:00 AM on Friday, July 19, absolutely no exceptions! If you don't verify, it won't sell! The Fair Board oversees the fair auction, so if you have any questions, please contact them at the Fair Office, [sifair@mahaska.org](mailto:sifair@mahaska.org), or 673-7004.

- 1 Market Bird Entry (this includes multiple market birds in one cage as an entry or an individual market bird, not both)
- 1 Rabbit Entry (this includes Meat Pen as one entry or an individual rabbit, not both)

## 4-H T-shirts

4-H'ers must wear 4-H t-shirts while exhibiting at the fair. We have a limited supply of the green clover design available for \$10.00. The new basic Mahaska County 4-H t-shirts are available for \$15.00 and come in black with white ink, green with white ink, and white with green ink. You can purchase them at the Extension office until July 11 and anytime during the fair. We have a limited supply of Adult Small-2XL.

## Exhibitor Numbers for Shows

Exhibitor numbers are required for any animal shows (excluding Pets and Swine). You may pick up your pre-assigned number from the 4-H Office prior to your show. We also have numbers for FFA exhibitors. If you are in both 4-H & FFA, make sure you grab the correct number! **Please note that the 4-H Office will only be open until 5:00 PM each day, plan accordingly. SWINE EXHIBITORS DO NOT NEED NUMBERS!**

## Copyright & Alcohol Exhibit Information

As you prepare exhibits for the fair, please be cautious of copyright/trademark use. DO NOT copy anything unless you have permission. If you purchase a pattern or magazine that is used for an exhibit, then you have purchased the right to use the items. You need to get permission for anything else. Always remember to site your sources! Copyright help sheets are available at the Extension office. If using Pinterest, find the original source. DO NOT use [www.pinterest.com](http://www.pinterest.com) as your source! Also, please remember that NO alcohol images or items may be used with a 4-H exhibit. Example: Wine bottle lamps, beer bottle cap jewelry, beer breads, etc. 4-H members are not old enough to purchase alcohol; therefore, they are not able to use items related to alcohol.

## Design Elements & Art Principles

4-H'ers are **required** to include explanations of Design Elements or Art Principles if they will exhibit *Sewing, Visual Arts, or Home Improvement* exhibits at the fair. Please add your explanations to the back of your Goal Sheet for each exhibit in the categories listed above.

Help Sheets for Design Elements & Art Principles can be found at the Extension office and on our website. The judges at the fair do not want to see, “The element I used was color”.

Instead, the judges want to see *how* the element was specifically used.

Explain in your goal sheet about the specifics of the element or principle. For example, “I like how my eyes are drawn to the mix of colors on this quilt. Each color relates to the other and causes eyes to travel around the entire quilt.”

**Design Elements:**

*Line, Shape, Color, Texture, & Space*

**Art Principles:**

*Rhythm, Proportion, Emphasis, & Balance*

The following are requirements for the above listed classes.

Exhibitors who have completed:

*4th-6th grade—minimum of 1 element of design*

*7th-8th grade—minimum of 2 elements of design*

*9th-10th grade—minimum of 1 art principle*

*11th-12th grade—minimum of 2 art principles*

## State Fair & County Fair Livestock Info

**Iowa State Fair Livestock Exhibiting:** If you plan to exhibit livestock at the 2019 Iowa State Fair, please visit [www.extension.iastate.edu/4h/projects/livestock](http://www.extension.iastate.edu/4h/projects/livestock) to browse the project areas that interest you. Some updated livestock information has been added for the 2019 Iowa State Fair. If you plan to exhibit at the Iowa State Fair, you must order your tickets by July 20. Visit <https://www.extension.iastate.edu/4h/state-fair-exhibitor-information>.

Iowa State Fair rules for preparing for exhibition and exhibiting apply at the Southern Iowa Fair. Substitute showmen must be pre-approved by the Superintendent and 4-H Staff Show Official. Substitute showmen will only be permitted if sickness or injury prevents original exhibitor from exhibiting. Staff may request a doctor's note.

If assistance is needed for a child, please contact a 4-H Superintendent prior to the show. A Special Accommodations Form is available, which should be filled out prior to the event.

If anyone removes members' animals before the specified release time, said member will lose all premiums and awards and will not be permitted to go through the auction or exhibit in that project area again next year. *Animals being exhibited in one division or show may not also take part in a different show.* Ex. Bottle Lambs being exhibited as a Bottle Lamb and then being in the sheep show, this is not permitted. Any animals sold at/after the county fair are no longer a 4-H project, those members may no longer exhibit that animal in a 4-H show at the county, state, or interstate level in 2019.

Last-minute changes will be posted and announced at the fair.**

## Sheep & Goat Scrapie Tag Requirements

**IF YOU ARE GOING TO EXHIBIT SHEEP AND/OR GOATS AT THE SOUTHERN IOWA FAIR, PLEASE READ THOROUGHLY!**

Animals arriving at the fair without scrapie tags in place will not be permitted to be exhibited!

**Sheep & Goats (Meat, Dairy, Myotonic) -**

All sexually intact sheep must have an individual Scrapie Flock of Origin identification tag (Ex. IA] 234-5678) or another official Scrapie tag. All sexually intact goats must be identified with an individual Scrapie Flock of Origin identification tag (Ex. IA 1234-5678), another official Scrapie tag, or by an official tattoo registered with USDA (to register, call 1-866-USDA-TAG; 1-866-873-2824). Wethers less than 18 months of age are required to have an individual identification and a scrapie tag may be used, but a scrapie tag is not required, unless going through the auction at the fair.

## Farm Safety Stations

We are partnering with North Mahaska FFA to offer Farm Safety Stations during the fair. These stations are generally formatted for youth, but anyone is welcome to participate. Farm Safety Stations will be offered on **Wednesday, July 17** at **10:00-11:00 AM, 3:00-4:00 PM, and 6:00-7:00 PM.**

Participants will start at the 4-H Building near the 4-H Office and be given instructions for completing each station. Participants will spend up to 10 minutes at each station learning about different aspects of farm safety, including ATV & Lawn Mowers, Sun Safety, Proper Hand washing, etc. After completing each station, participants will check-out at the 4-H Building to receive their goodie bags. If you have any questions about the Farm Safety Stations, please contact Ashtin Harris or Megan Ver Steegh.

## Mahaska County Goal Sheet

The Mahaska County Goal Sheet is a standard form that all 4-H'ers must use for their non-livestock exhibits (except photography and posters). This form is available at the Extension office and on our website at <http://www.extension.iastate.edu/mahaska/page/4-h-fair-award-forms>. The goal sheet contains three questions that must be answered. All Visual Arts, Home Improvement, and Clothing/Sewing exhibits must also include explanations of Design Elements and/or Art Principles as described in the fair booklet. You may either type or handwrite your goal sheets; however, Intermediates and Seniors should plan to type their goal sheets with full, complete sentences. These forms must be completed prior to arriving at the fair on Monday, July 15th. Completed forms should be attached to your exhibits, as well as an entry tag. If you aren't sure what to expect for static exhibit judging, please visit with other experienced club members, your leaders, or call Amy at 641-673-5841 ext. 28. Amy will be out of the office most of the week prior to fair, since she'll be setting up the temporary 4-H office on the fairgrounds that week.

## Preparing Exhibits for the Fair

As you prepare your exhibit for the Southern Iowa Fair, please remember to fill out a **goal card** and **entry tag** for each exhibit you will bring (prior to arriving at the fair). An entry tag must be attached to each exhibit, as well as a goal card. You may tie, pin, or tape the entry tags and goal cards to your exhibits. Many exhibitors put their goal sheet into a sheet protector and run the entry tag through the punched hole in the sheet protector to tie onto the exhibit.

The **entry form** will be filled out to list all exhibits that will be judged on Monday, July 15. All of these items can be found at the Extension office and on our website listed above.

**Food & Nutrition Exhibits** must fit the requirements to be eligible to be judged. A NEW Guide has been posted to the Extension Store and can be downloaded from: <https://store.extension.iastate.edu/product/6434>. All canned foods must include a 4-H Canned Food Label (available at the Extension office and on our website).

As you prepare any exhibits for the fair, if you have any questions, please contact your leader, a superintendent listed in the fair rule booklet, or the Extension office at 641-673-5841.



## Barnyard Games at the Fair

We will hold \*Barnyard Games (formerly Ag Olympics) at this year's county fair. We will have divisions for 4th-6th graders, 7th-9th graders, and 10th-12th graders. Different tasks will need to be performed by the teams and the top overall teams will be awarded some fun prizes. This is open to all, not just 4-H & FFA members and families. Ag Olympic Games will be held on Thursday, July 18th following the MCARD & Farm Bureau BBQ in the Pavilion.

*Registration will be open from 8:00 AM on Monday, July 15 and will close when slots are filled or until 3:00 PM on Thursday, July 18.* Teams must consist of 4 members in the same age division. Exceptions can be made if 3 of the 4 members are of the same age, but the other member must be in the age division immediately below or above the group.

*Ex: Team consisting of two 7th graders, one 8th grader, and one 6th grader is acceptable. Team consisting of two 10th graders, one 11th grader, and one 5th grader is not acceptable.*

\*Please note that extreme weather (heat or storms) will cancel this event.

## Static Exhibit Ribbon Clarification

Several families asked our staff to clarify the static exhibit ribbon placings during last year's fair. Please read below for details:

Purple 4-H Ribbons mean that the exhibit is State Fair CONSIDERED, not selected. A judge has decided that the exhibit and goal sheet are state fair quality, but will go against other exhibits in the project area to actually be selected. Blue 4-H Ribbons mean that the exhibit is high quality, but not considered for the state fair. It is possible that a judge can change a blue ribbon to purple during the state fair selection process. It is not common, but it is possible. The state fair selection process is closed to the public. Exhibitors will find out if their exhibit was selected on Tuesday morning, July 16. Only one exhibit per member may be selected to advance onto the state fair.

## 4-H Horticulture Judging

Any 4-H'er planning to exhibit Vegetables on a plate, on a tray, or in a booth, Floral Arrangements, Cut Flowers, Collections of Flowers, Container Grown Plants, Herb Collections, Containers of Berries, Follow-Up Hort Exhibits, Garden Journals, or Melon Heads must take part in the **4-H Horticulture Judging** between 2:00-4:00 PM in the 4-H Building on **Tuesday, July 16**. Exhibitors may begin signing in at 1:30 PM, but must be signed in by 3:00 PM. Full details about Horticulture Judging can be found on pages 52-53 of the 4-H & FFA Fair Rule Booklet. This class is different from 4-H Exhibits Class 10230

Horticulture under Agriculture & Natural Resources.

*What's the difference?*

Class 10230 is an exhibit that shows learning about the growth, use, and value of plants, small fruits, vegetable and flower gardens, and landscape design, these exhibits are judged by the Ag & Natural Resources judge on Monday.

4-H Horticulture Judging on Tuesday includes fresh garden crops, cut flowers and herbs, and other arrangements, berries, as well as the special "Melon Head" and "Garden Journal" classes.

The Communications Event Judging will take place on **Tuesday, July 16** from 9:00-11:00 AM & 12:00-2:00 PM for Educational Presentations, Share-the-Fun, and Extemporaneous Speaking on the Free Stage.

Working Exhibit judging will take place on **Wednesday, July 17** from 9:00 AM-Noon at the Free Stage.

The public is invited and encouraged to attend these events.

### REMAINING CLINIC:

July 2—6:30 PM— Heather Gardner will focus on classes and what the judge looks for. Evening will start with halter/showmanship class, English class, then horsemanship and other pleasure classes.

### VET CHECK OPTIONS: (Vet Check does NOT count as a clinic)

#### Thursday, July 11—Optional Pre-Fair Vet Check 6:30 PM

This vet check will be held at the Southern Iowa Fairgrounds. Horses will be checked by a vet and Official Health Papers will be provided free of charge. Papers will be good for county and state fair (if needed). Exhibitors taking part in this option will be able to arrive at the fair and check in with the 4-H horse superintendents, since they have already been checked by a vet.

#### Tuesday, July 16—Fair Check-in 4:00-6:00 PM

Horses will be checked (trailer to trailer—park to the west of the Horse Barns) by an Official Fair Veterinarian. Horses can stand outside of the trailer, but may not check into stalls until the vet has checked them over. Exhibitors may use the wait time to bring tack, bedding, etc. to the stalls. Official Health Papers will not be issued.

### Alternate Options

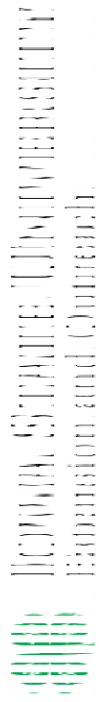
